Waukesha Massacre

The life and crimes of accused Waukesha Christmas parade killer Darrell Brooks

MILWAUKEE — The man who turned a quaint, small town Christmas parade into a blood-soaked nightmare that left six dead and over 60 injured is a career criminal who's spent more than half of his life trapped in a revolving door of incarceration, drug abuse and violence.

Darrell Brooks, 39, allegedly used a red Ford Escape to plow through revelers at an annual Christmas celebration in Waukesha, Wisconsin, on Sunday (Nov 21, 2021), but his life of crime started 22 years ago when he was just 17 years old.

Over the next two decades, Brooks would proceed to wreak havoc across three states as he racked up convictions for **abusing his partners, raping and impregnating a teenager and a consistent streak of other violent crimes.**

A review of his history — patched together from court documents, criminal records, interviews and public records — reveals that all along the way, not a single social safety net caught him, until it was too late.

A life of crime

A year after Brooks was charged with his first felony in 1999 at age 17 for substantial battery intending bodily harm, he was given three years of probation. But he soon found himself tangled up in the law once again, being hit with misdemeanor charges in 2002 and 2003 over separate incidents.

In 2005, he moved to Reno, Nevada, in a bid for a fresh start but within a year, he was



charged with statutory sexual seduction and contributing to the delinquency of a minor after he raped and impregnated a teen girl who he claims told him she was 18 at the

time.

He settled the case by pleading guilty but was ordered not to contact the victim — a requirement he repeatedly violated by calling the teen using a stolen phone card and confronting her at a bus stop, landing him back in jail where he served just 129 days, records show.

As a result of that conviction, Brooks was forced to register as a sex offender in the state and during his time behind bars, he participated in a 2007 documentary called “Crystal Darkness.”

Escalating violence

Between 2009 and 2011, Brooks was in and out of jail for a series of crimes, including resisting or obstructing an officer, strangulation and suffocation.

During a 2011 bust, he was charged with restricting or obstructing an officer for a second time after he was pulled over for not wearing a seatbelt.

“During a traffic stop, a Milwaukee police officer jumped inside Brooks’ car, fearing he was about to be run over,” the Milwaukee Journal Sentinel reported of the incident.

“As Brooks began to drive away while the officer was talking to him, the officer got inside the car and wrestled for control of the steering wheel.”

Eventually, the officer stopped the car and

removed the keys as Brooks ran off. He was later found hiding in a children’s playhouse on the same block and was taken into custody.

In 2016, Brooks was busted again for failing to register as a sex offender and in July 2020, he fired a gun at his nephew during a fight over a cellphone.

Anaji Brooks told police he got into a friend’s car following the dispute and was driving away when his uncle “walked into the front yard with a gun and fired one shot at them,” leaving the man in fear of his safety, court papers say.

Officers soon found Brooks with a stolen Beretta 9mm handgun and a clear plastic baggie with three multi-colored methamphetamine pills inside, records show.

Now, Goguen is wrapped up in a mystery that just keeps getting messier, as person after person has apparently tried to take him down — only to end up taken down themselves.

Originally from Bedford, Mass., Goguen joined the venture investment firm Sequoia Capital, based in Menlo Park, Calif., in 1996. It was already known for taking smart early bets on companies, including Apple and Cisco, and would later generate big buzz — and money — for getting behind brands that would become enormous: Google, YouTube, PayPal and Instagram among them.

He had gotten a share of the Google deal and, as Bloomberg reported, “frequently appeared on the Forbes Midas List for his ability to find and fund winning technologies.”

But things came to a crashing halt in 2016 when his former mistress Amber Baptiste, an exotic dancer from Canada, accused him of “constant sexual abuse,” including “countless hours of forced sodomy,” court papers say. He also demanded that she refer to him as “king” and “emperor,” according to the filings. In 2012 Baptiste said, she underwent surgery for a ruptured anal canal after Goguen “forcibly sodomized her and left her bleeding and alone on the floor of a hotel room in a foreign country,” court papers claimed.

Goguen won a countersuit in the three-year legal battle, eventually securing a restraining order against Baptiste from filing any similar suits against him. But the allegations cost him his job at Sequoia Capital in Silicon Valley, where he had been a longtime partner.

At the time a Sequoia spokesman told TechCrunch that “while the firm understood ‘these allegations of serious improprieties’ to be ‘unproven and unrelated to Sequoia’ its management committee had nevertheless ‘decided that Mike’s departure was the appropriate course of action.’”

Despite the high-profile exit, Goguen is still worth more than \$5 billion, according to a source.

Goguen, began spending more time in Whitefish, a town of just over 7,000 residents, where he built a sprawling 75,000-

square-foot mansion with an additional 30,000-square-foot nuclear-grade bunker that can accommodate up to 25 people for a year. He lives with his fourth wife.

There, he runs several businesses, including Casey’s Whitefish, a pub and restaurant, and Two Bear Capital, a firm that invests in “early stage companies with disruptive innovations,” including biotech and cybersecurity, according to his LinkedIn page. He also funds Two Bear Farm and is behind Two Bear Air Rescue Foundation, a non-profit that provides “world class aviation support” to law enforcement and others for search and rescue, free of charge.

He started Amyntor Group LLC, a private defense contractor that, at one point, was in line to create a private spy network for the Trump administration, according to [BuzzFeed](https://www.buzzfeed.com/michaelgoguen). Negotiations were stalled because Goguen could not obtain a security clearance with the US government because of the allegations of sexual abuse, court papers allege.

Meanwhile, another ghost from his past was about to haunt him. Bryan Nash was a former workout buddy from California, who had reluctantly accompanied Goguen to bars and strip clubs.

In 2019, federal authorities indicted Nash on 10 counts of stalking and extortion; according to the criminal complaint, Nash had threatened to reveal unspecified secrets unless Goguen paid him \$15 million, and also emailed members of Goguen’s family. In May 2020, Nash pleaded guilty to blackmailing Goguen, and was later sentenced to five years of probation.

This is where Matthew Marshall comes in. A former Marine and alleged CIA operative, he once headed up the Amyntor Group — and is now the lead plaintiff in the civil suit filed against Goguen in February and amended in September.

Although Marshall, now 51, had been recruited by Goguen in 2013 to set up the private security contracting business, he alleges in his lawsuit that he soon became a reluctant fixer for the billionaire, arranging the purchase of luxury homes and vehicles for members of his harem, and spying on and intimidating his enemies.

Whitefish, Mont., is known for fly fishing and hiking trails studded with yellow Aspen trees. But after Silicon Valley billionaire Michael Goguen took up residence in the Rocky Mountain town several years ago, he transformed it into his private fiefdom: a dark banana republic where he allegedly controls local law enforcement — and a “harem” of young women.

The bombshell allegations, which also include claims of Goguen ordering his security chief to kill detractors, are contained in a lengthy civil complaint recently filed in United States District Court for the District of Montana.

According to the court papers, Goguen, 57, employs hundreds of residents in companies he controls, and owns a series of luxury “safe houses” where he takes dozens of young women for sex. He has a spreadsheet documenting his sexual encounters with 5,000 women [lest he forgets?], and even outfitted a local bar he owns with a basement “boom boom” room, which features a stripper pole. The underground enclave is allegedly used “to maintain women for the purpose of committing illicit sexual activity. “The complaint, which seeks more than \$800 million in damages, was filed by four former employees who set up Goguen’s Amyntor Group LLC, a Whitefish-based security contractor that had clients around the world.

Pfizer Documents Reveal Over 1,200 Vaccine Deaths Over 90-Day Trial Period

The Food and Drug Administration (FDA) has released the first batch of documents related to Pfizer's COVID-19 vaccine program after a federal judge ordered that they must comply with a massive FOIA [Freedom of Information Act] request.

The request was filed by the Public Health and Medical Professionals for Transparency group, which consists of more than 30 professors and scientists. They requested any and all data that factored into the agency's decision to authorize Pfizer's vaccine for emergency use.

"The entire purpose of the FOIA is to assure government transparency," the plaintiffs argue. "It is difficult to imagine a greater need

for transparency than immediate disclosure of the documents relied upon by the FDA to license a product that is now being mandated to over 100 million Americans under penalty of losing their careers, their income, their military service status, and far worse." The FDA was ordered to comply after challenging the request in court. The agency had previously stated they would need a whopping 55 years to process the request. 🤔

An official Pfizer document titled Cumulative Analysis of Post-Authorization Adverse Event Records Reports, obtained via the request, contains data on adverse reactions to the vaccine. According to the document, there were tens of thousands of adverse effects to the vaccine recorded over a 90-day period from December 1st, 2020 – February 28th, 2021.

Over this period, there were 1,403 cases of cardiovascular issues, accounting for 3.3% of the data set.

More alarmingly, **there were also 1,223 recorded fatalities over the 90-day time period.**

The data only included "serious" adverse effects. Any side effects deemed "non-serious"



were to be processed within 90 days in a separate report. Data included in this document was also collected voluntarily, according to the document's methodology section.

Nevertheless, the paper concludes that the "review of available data" deemed the vaccine safe and ready for market. Emergency use was authorized by the FDA soon after.

More documents will be released in the coming weeks. Public Health and Medical Professionals for Transparency filed another motion that would force the FDA to expedite the release of requested documents.

Federal Judges Slap Down the Biden Administration—Hard

The judges are finally doing their jobs again. In August, I penned a [column](#) lamenting that in COVID-19 cases the courts seemed have gone AWOL. The sole exception was the Supreme Court’s 2020 decision in *Roman Catholic Diocese of Brooklyn v. Cuomo* ([pdf](#)), which blocked New York State closure rules discriminating against houses of worship. Otherwise, courts were deferring to government mandates, often relying on the old case of *Jacobson v. Massachusetts* ([pdf](#)) [without regard](#) to whether *Jacobson* was really a good authority for COVID-19 restrictions.

But now the federal judiciary is pushing back against the Biden administration’s contempt for liberty, the Constitution, and the rule of law.

On Aug. 26, the Supreme Court decided *Alabama Association of Realtors v. Department of Health and Human Services* ([pdf](#)). The Centers for Disease Control and Prevention (CDC), purportedly relying on a law that authorizes actions such as fumigation and disinfection, sought to re-write every residential lease in the country. The Supreme Court called the CDC’s interpretation of the law a “stretch” and struck down the agency’s order:

“[The Government’s read[ing] [of the statute] would give the CDC a breathtaking amount of authority. It is hard to see what measures this interpretation would place outside the CDC’s reach This claim of expansive authority ... is unprecedented.”

The Administration Doubles Down on Dictatorship

The high court’s decision was a warning to the Biden administration. Yet the administration ignored it and doubled down. “[The Big Guy](#)” decided he knew best for the rest of us: Everyone had to be vaccinated. So the administration issued not one, but *three* vaccination mandates:

- The Occupational Safety and Health Administration (OSHA) imposed a vaccination diktat on companies with more than 100 employees.
- The Centers for Medicare & Medicaid Services (CMS) issued a similar decree on health care providers.
- The Big Guy issued an executive order stating that the government would no longer contract with (or permit subcontracts to) companies with unvaccinated employees.

Just as the CDC had tried to convert a fumigation statute into power over residential leases, OSHA twisted a law directed at immediate job emergencies into a sweeping public health measure. CMS and the president likewise inflated administrative provisions into public health laws.

Each of these mandates purported to override state and local public health regulations.

The number of people affected shows how far the federal government now exceeds its constitutional limits. The OSHA mandate covered two thirds of the private sector workers in the country. The CMS decree affected 10.3 million people. The president’s executive order drew a bead on a fifth of the national workforce.

The administration’s apparent goal was to transfer public health policy from the states, where the Constitution places it, into the grip of [Dictator Joe](#).

The Judicial Response

On Nov. 12, a unanimous three-judge panel of the U.S. Court of Appeals for the Fifth Circuit put a hold on the OSHA mandate. The case was *BST Holdings v. OSHA* ([pdf](#)). The judge writing the court’s opinion was Kurt D. Engelhardt.

On Nov. 30, a Louisiana federal court stayed the CMS order. The case was *Louisiana v. Becerra* ([pdf](#)). The jurist was Terry A. Doughty. The same day, a Kentucky federal judge stayed the executive order on federal contractors. The case was *Kentucky v. Biden* ([pdf](#)). The judge was Gregory F. Van Tatenhove.

Judge Tatenhove’s stay applied only to three states, but on Dec. 7, R. Stan Baker, a Georgia federal judge, made the stay national in scope. The case was *Georgia v. Biden* ([pdf](#)).

At least one decision has gone the other way. A Florida district court upheld the CMS mandate and on Dec. 6, the U.S. Court of Appeals for the 11th Circuit affirmed (*Florida v. Department of Health and Human Services* ([pdf](#))). But unlike the Fifth Circuit case, this decision was not unanimous: Judge Barbara Lagoa strongly dissented.

Aside from the 11th Circuit, all these courts found that the administration’s orders grossly exceeded the power Congress had given the executive branch.

Some of the judges expressed constitutional doubts as well. In the Fifth Circuit (OSHA) case, Judge Engelhardt pointed out (as I had in an [earlier essay](#)) that refusing to receive a vaccination is not the kind of “economic activity” the Supreme Court says can be

reached under the Commerce Power. Judge Lagoa, writing in her 11th Circuit dissent, echoed that comment. In Kentucky, Judge Van Tatenhove added, “[There is a serious concern that Defendants have stepped into an area traditionally reserved to the States, and this provides an additional reason to temporarily enjoin the vaccine mandate.”

There’s a rule of constitutional law—known as the Major Questions Doctrine—that when Congress wishes to intrude on a matter of traditional state concern, Congress must do so in clear language. This is a very prominent rule studied in law school constitutional law courses. Of course, the Biden administration knew all about it, but chose to ignore it. Judges Engelhardt, Lagoa, and Doughty all criticized the administration for doing so.

The Judges Question the Administration’s Ethics

Typically, judges don’t accuse government actors of bad faith. But **the Biden administration’s conduct was so egregious that several judges mentioned it.** Judge Van Tatenhove pointed out that when Biden issued his executive order, he violated the Competition in Contracting Act. Judge Doughty observed that the administration had deliberately disregarded three specific legal requirements imposed by the Social Security Act. Judge Doughty explained how the CMS avoided giving legally required public notice:

“It took CMS almost two months, from September 9, 2021 to November 5, 2021, to prepare the interim final rule at issue. Evidently, the situation was not so urgent that notice and comment were not required. It took CMS longer to prepare the interim final rule without notice than it would have taken to comply with the notice and comment requirement.”

Several judges commented on the dishonesty of the administration's legal defenses. Judge Van Tatenhove declared that "[I]t strains credulity that Congress intended ... a procurement statute, to be the basis for promulgating a public health measure such as mandatory vaccination." Judge Doughty found the CMS order "arbitrary and capricious." In response to the CMS claim that its order was designed to increase efficiency, Judge Doughty labeled that a mere "pretext"—which means it was a lie.

Judge Engelhardt also responded to the administration's dubious ethics. OSHA claimed it received power to impose vaccinate mandates from an emergency shortcut designed for immediate workplace threats from previously unknown chemicals and similar substances. Judge Engelhardt noted that:

- This "emergency" had endured for nearly two years. When the administration finally decided to act, it took two months to do so. Obviously, the administration really didn't believe there was an emergency. It merely said so to defend its overreach.
 - "[C]ourts and the Agency have agreed for generations" that the emergency shortcut had to be "delicately exercised." But "the Mandate is a one-size-fits-all sledgehammer that makes hardly any attempt to account for differences in workplaces (and workers) that have more than a little bearing on workers' varying degrees of susceptibility to the supposedly 'grave danger' the Mandate purports to address."
 - OSHA previously had conceded it had no such authority.
 - The "sledgehammer" was both "underinclusive" and "staggeringly overbroad," violating yet another requirement of the statute.
- Judge Engelhardt finished with these words:

"The Constitution vests a limited legislative power in Congress. For more than a century, Congress has routinely used this power to delegate policymaking specifics and technical details to executive agencies charged with effectuating policy principles Congress lays down. ... But health agencies do not make housing policy, and occupational safety administrations do not make health policy. *Cf. Ala. Ass'n of Realtors* In seeking to do so here, OSHA runs afoul of the statute from which it draws its power and, likely, violates the constitutional structure that safeguards our collective liberty."

These cases are extraordinary slap-downs of a sitting president. The slap downs are extraordinary not merely because the president lost, but because so many judges felt the need to highlight the Biden administration's dishonesty and contempt for the rule of law.

Prosecutors say that Griffin stated that he believed that there is a “wanton wh*re” at the “core of any” woman and “a woman is a woman regardless of her age.” Prosecutors said that Griffin used apps to seek “parents who would allow him to train their minor daughters to be sexually subservient.”

Griffin allegedly told one mother that he believed that “**one of the big lies of this society is that women are delicate innocent angels and they are in actuality, naturally, the dirtiest sl*ts possible, in EVERY metric.**”

it's inaugural iteration, the FBI has identified and recovered around 3,600 children who have been sexually exploited as part of Operation Cross Country. The massive undertaking targets casinos, truck stops and websites that offer escort services. Authorities in Portland said that the Oregon operation recovered 20 adult prostitutes, many of whom had been trafficked since they were 13 or 14-years-old.

“Sex traffickers are selling kids—our kids—every day in motels, on the street and in our neighborhoods for sex. Over time, the children age into adulthood—but the impact of this victimization continues for each of them, their families, and the community as a whole,” said Greg Bretzing, Special Agent in Charge of the FBI in Oregon.

Disturbing new details emerged this week from the federal charges against CNN senior producer John Griffin, 44, stemming from allegations that he tried to and did groom children for sex.

Griffin, of Stamford, Connecticut, was arrested on Friday after a federal grand jury

FBI RESCUES 168 CHILDREN FROM "LIVING NIGHTMARE" IN NATIONWIDE SEX TRAFFICKING STING

Dozens of children have been rescued and 281 pimps have been arrested as part of a child sex trafficking sting over the past week, according to information released today from the FBI.

The 168 children, many of whom had never been reported missing, were recovered during an annual nationwide FBI crackdown, according to CBS. Dubbed Operation Cross Country VIII, it's now in its eighth year. While arrests were made across the country, the largest number of juveniles recovered were the 18 found in the Denver area, followed by 16 in the Cleveland area.

“Child sex traffickers create a living nightmare for their adolescent victims,” Leslie R. Caldwell, Assistant Attorney General for the Criminal Division of the Department of Justice, said in the FBI's release. “They use fear and force and treat children as commodities of sex to be sold again and again.”

Jackson, Miss., had the most pimp arrests with 19, followed by 17 arrested in New Or-

Amid many of the issues surrounding sexual harassment issues at CNN, including the firing of Chris Cuomo over his involvement with his brother's sexual harassment cases, the information that Project Veritas has now involved a producer who had been openly fantasizing about his fiancé's underage daughter to a former sex worker.

Veritas investigated the proof which included texts, facetime videos, and photographs, and found them to be credible and then sat down with the woman who turned the information over to the organization to discuss what she had given them on camera.

The woman had a 10-year history with the producer but only met in person twice. Apparently, he trusted her enough to begin not only sharing his attraction toward his fiancé's underage daughter but asked for this woman to share in his fantasies. The woman said she "felt disgusted" but continued to press him to continue for the sake of gathering more evidence.

I won't repeat a lot of what the man said here as it feels too disgusting to type out, but one of the actions he took was to send

photos to the woman of the girl in a bathing suit and graphically describe how the bathing suit bottoms were closely cut.

Project Veritas founder James O'Keefe has said they've turned all the evidence into the proper authorities and have reached out to CNN for comment. As of this writing, they have yet to respond.

This producer isn't the only CNN employee stung over sexual intentions to underage girls.

John Griffin, 44, was a producer for Cuomo who had utilized various websites to arrange sexual activities with girls, even

The indictment was unsealed this week, and it details some of the disgusting allegations against John Griffin, who was arrested on Friday by FBI agents. Griffin allegedly used a BDSM site to find parents who would then provide their daughters to him to 'train' in "spanking" and "c-k worship." According to the indictment, he tried to lure at least four girls, aged 16, 14, 13, and 9 years old.

Clearly, there's an issue at CNN that needs to be investigated.





