Canadian Doctor: Unvaccinated Patients are Mentally Ill and Should be Put on Psychiatric Medication

Doctors in Ontario are reportedly being advised to consider using psychiatric medicines on patients who refuse the vaccine.

During an interview at 'Let Freedom Reign Tour,' Physician and Cancer Researcher Dr. William Makis claimed that the College of Physicians and Surgeons of Ontario sent out a note to doctors implying that their unvaccinated patients may be suffering from a mental illness and should be prescribed psychiatric medicine.

"So this has come out recently out of the College of Physicians and Surgeons of Ontario. The college sent out a letter or a memo to all the doctors in Ontario suggesting to them now, so far, they're not mandating it, they're just suggesting it, that any of their unvaccinated patients, that they should consider that they have a mental problem and that they should be put on psychiatric medication. So far, it's just a suggestion," Dr. Makis told Lynn Tyler Thompson.

"But the College of Physicians and Surgeons of Ontario should not be making these kinds of suggestions. This is extremely unethical and this is a

very, very slippery slope. If they're suggesting that people who wish to have bodily autonomy and don't want an experimental vaccine, that there may be something mentally wrong with them, that is a very, very dangerous, slippery slope that we're on," he continued.

The Gateway Pundit reached out to the College of Physicians and Surgeons of Ontario for comment.

This explosive expose comes after Dr. Makis spoke about the death of 93 doctors after the vaccine rollout.

It can be recalled, Dr. William Makis MD wrote a letter to the Canadian Medical Association (CMA), requesting that they look into the sudden

rise in mortality among Canadian medical professionals after the implementation of mandated vaccinations for medical personnel.

On his Gettr account, Makis claimed that fact-checkers were caught lying about a Canadian doctor's sudden death.

The Gateway Pundit previously reported that three physicians at Canada's Trillium Health Partners-

Mississauga Hospital died unexpectedly in the same week.

According to the nurse who shared the information, the three doctors died after the hospital started mandating the fourth Covid shot for their employees.

"Three physicians at the Mississauga hospitals have died this week," the nurse told Monique. "1st memo Monday, 2nd Tuesday, 3rd Thursday. [The] cause of death wasn't shared in the memo, but how many times have 3 doctors died in 1 week, days after the hospital started administering the 4th shot to staff."

The three physicians who died the same week were Dr. Lome Segall (July 17), Dr. Stephen McKenzie (July 18), and Dr. Jakub Sawicki (July 21).

The hospital claimed that the social media rumor that their deaths were related to the COVID-19 vaccination is "simply not true."

Dr. Makis claimed Dr. Lome Segall that he died suddenly of a pulmonary embolism, blood clots in the lungs, not cancer and that he was fully vaccinated when he died, according to his sources.

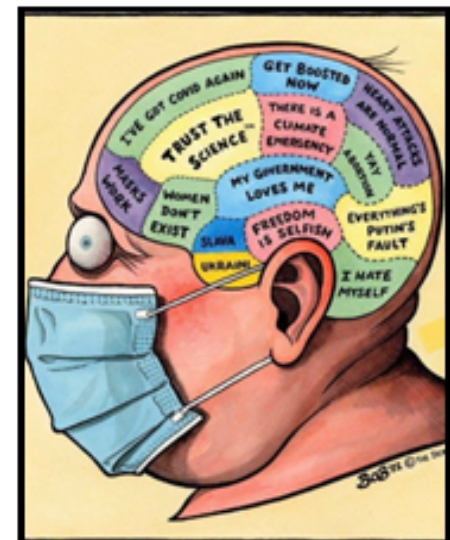

FBI Issues 'National Public Safety Alert' on Widespread Child Extortion Schemes

December 19, 2022

The FBI on Monday issued a "national public safety alert" due to an increase in extortion scams aimed at thousands of children and teenagers, warning about the possibility that more Americans could be targeted over the Christmas holiday season.

In a news release, the bureau said that more than 3,000 minor victims were targeted in the past year and has received more than "7,000 reports related to the online financial sextortion of minors." More than a dozen suicides were also associated with the trend, the FBI said.

Most of the schemes originate not in the United States, but in other countries, the FBI said. Much of the attacks, the agency added, originate from the West African nations of Ivory Coast and Nigeria, although it's not clear if it is a coordinated effort by one group.

"As many children enter winter break this holiday season," the release said, "the FBI and our partners implore parents and caregivers to engage with their kids about financial sextortion schemes so we can prevent them in the first place."

Explaining the anatomy of a scam that targets minors, the FBI said that predators convince the minor to produce a compromising video or photo before they obtain the image or video and threaten to release them unless they send money or gift cards, according to the release.

"Often the predators demand payment through a variety of peer-to-peer payment applications. In many cases, however, predators release the images even if payments are made. The shame, fear, and confusion that victims feel when

they are caught in this cycle often prevents them from asking for help or reporting the abuse."

The FBI also said it saw a 10-fold increase in reports in the first six months of 2022, as compared with the same time period in 2021, according to the release.

Noting "a horrific increase in reports of financial sextortion schemes targeting minor boys," FBI Director Christopher Wray said that "many victims who are afraid to come forward are not even included in those numbers."

Financial extortion schemes take place on websites and apps where young people feel most comfortable, such as social media sites, gaming sites, and video chat applications, according to

the FBI. The predators will often use fake female accounts and go after minor males between the ages of 14 and 17, the bureau said, adding that there are younger victims.

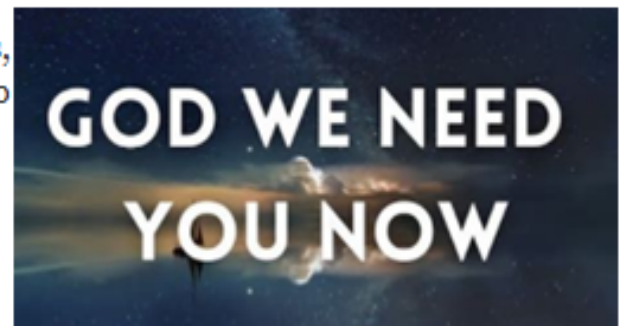

Rachel Levine Ripped for Demanding Censorship of 'Misinformation' on 'Gender-Affirming Care' for Kids

A high-level Department of Health and Human Services official requested big tech companies censor “gender-affirming care” information directed at children.

HHS Assistant Secretary Rachel Levine, a man identifying as a transgender woman, originally requested squelching of such “misinformation” in May. The video gained traction on social media after Christmas break as conservatives reacted to a government official’s call for censorship.

During a May 27 zoom address to the Federation of State Medical Boards in New Orleans, Dr. Levine spoke about the need for the government to “address health misinformation directly” and specified that includes encouraging Big Tech to combat health misinformation “beyond COVID-19.”

The doctor said, “So I’d like to just talk briefly about another area of substantial misinformation that is directly impacting health equity in our nation, and that is the health equity of sexual and gender minorities. There is substantial misinformation about gender-affirming care for transgender and gender diverse individuals.”

Levine then claimed that the country is “facing an onslaught of anti-LGBTQI+ actions at the state levels across the United States,” adding, “They are dangerous to the public health.”

Levine continued, saying, “The positive value of gender-affirming care for youth and adults is not in scientific or medical dispute.”

The official called for tech censorship to quell any dispute on the subject, adding, “And we need to use our clinicians voice to collectively advocate

for our tech companies to create a healthier, cleaner information environment.”

Critics of online censorship and encouraging children to undergo gender transitions ripped the video on Twitter.

The American Conservative senior editor Rod Dreher suggested Levine was a fascist, tweeting, “When fascism comes to America, it will be under the guises of Health and Safety.”

Claremont Institute Lincoln fellow Terry Schilling argued that Levine’s statements were worse than communist propaganda. He wrote, “Even the communists didn’t promote evil like this. They at least lied to make themselves look more competent. This is something different. They are still in the destruction phase of this nation. They know the opposition is strong and that’s why it needs to be shut down.”

After seeing the clip, Christian pastor Timothy Alden remarked, “Evil is an understatement.”

Conservative journalist Ian Miles Cheong tweeted, “You’re not allowed to criticize Rachel Levine on other social media platforms. You will be banned.”

In another tweet he added, “America is in trouble.”

Libertas Institute president Connor Boyack advised, “**Protip: what the government labels ‘misinformation’ you can generally just call ‘information.’**”

Rep. Warren Davidson, R-Ohio, provided his followers a biology refresher to push back against Levine. He tweeted, “Admiral asserts ‘need’ for Ministry of Truth. To deny this: $xy \neq xx$. It takes male & female to reproduce. Every egg is x. Sperm is y or x. At conception (save exceedingly rare cases), the baby human is xy (male) or xx (female). Nothing changes reality. Embrace the science.”

Science vs Pseudo-science

The fate of the world as we know it is at stake. Pseudoscience is dominating the news. Grand Jury Request Goes Through In Florida: “They Won’t Be Able to Hide Anything”

“Everything they did, everything they knew about, will be transparent.”



Nine days after Florida Governor Ron DeSantis said, in a press release, that he would be asking the State Supreme Court to convene a Grand Jury to investigate “any and all wrongdoing” with respect to the Covid-19 injections, he, extraordinarily, received approval on Thursday (12/22/22) for that request.

The Florida Supreme Court granted Governor Ron DeSantis approval to impanel a grand jury that will investigate mRNA Covid-19 vaccine manufacturers and to release all of their data.

The grand jury, as suggested by the governor, will seek to require that big pharmaceutical companies reveal their data on safety and the benefits of the Covid-19 vaccines that they developed.

As we recall from Governor DeSantis’ mRNA accountability hearing, he and Surgeon General Dr. Joseph Ladapo made three major announcements.

“Anything they [the CDC] put out, you just as-

sume, at this point, that it’s not worth the paper that it’s printed on,” attested Governor DeSantis on December 13.

“And so, in Florida, we’re creating what we’re calling the public health integrity committee. It’s a committee of expert researchers that will be able to assess recommendations and guidance related to public health and healthcare, but particularly being able to offer critical assessments of things that bureaucracies like the FDA, CDC, and NIH are doing.”

2 LEADING FURTHER SURVEILLANCE INTO SUDDEN DEATHS

Florida will conduct surveillance into sudden deaths of individuals that received the COVID-19 vaccine in Florida, based on autopsy results. The state will collaborate with the University of Florida to compare research with studies done in other countries.

Doctors Jay Bhattacharya and Martin Kull-dorff will be serving as members of this Health Committee. So, when the CDC recommends vaccinations and masks for young children, there will be another entity of authority that will offer a second opinion with some weight.

This is a program being initiated by Florida Surgeon General Dr. Joseph Ladapo and team, where they will be studying the incidence of myocarditis within a few weeks following the jab.

“This is going to be a surveillance study working with some of our medical examiners in Florida,” Dr. Ladapo announced. “We’re also going to be working with the University of Florida, so there will be a component that has more of a research forum to it, but we will answer this question. It is a question that I’m sure keeps the CEOs of Pfizer and Moderna up late at night — hoping no one ever looks. But we’re going to look here in Florida.”

3 FILING A PETITION TO CALL A STATEWIDE GRAND JURY

The Grand Jury will investigate crimes and wrongdoing committed against Floridians related to the COVID-19 vaccine.

“We’ll be able to get the data whether they want to give it or not because, in Florida, it is against the law to mislead and to misrepresent, particularly when you’re talking about the efficacy of a drug. Just recently, Florida got \$3.2 billion through legal action against those responsible for the opioid crisis. And so, it’s not like this is something that’s unprecedented,” expressed Governor DeSantis.

“So today (December 13), I’m announcing a petition with the Supreme Court of Florida to impanel

a statewide Grand Jury to investigate any and all wrongdoing in Florida with respect to COVID-19 vaccines — and we anticipate that we will get the approval for that (they now did). That will be something that will be impaneled, most likely, in the Tampa Bay area. And that will come with legal processes that we’ll be able to get more information and to bring legal accountability for those who committed misconduct.”

The approval for the Grand Jury request is “so critical,” expressed Dr. Naomi Wolf on War Room

“They [the vaccine manufacturers] won’t be able to hide anything. Everything they did, everything they knew about, will be transparent.” Dr. Wolf continues, “And so, this is in a criminal investigation about wrongdoing committed against Floridians related to the COVID-19 vaccine.”

I’ve really got to hand it to Dr. Ladapo and to Governor DeSantis,” commended Dr. Wolf.

“They just follow the science! And so, they’re following the science into the morgue. They are going to lead further surveillance into sudden deaths of individuals that received the COVID-19 vaccine in Florida based on autopsy results. And they’re going to collaborate with the University of Florida and look at research from other countries. So that’s huge!” rejoiced Dr. Wolf.

- We live in a 1984 style surveillance state. This should be getting 24/7 media attention, however, our media is controlled by the CIA.

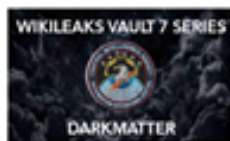

On March 23, 2017, WikiLeaks released the second portion of Vault 7, named Dark Matter. This release contains documentation for several CIA projects that infect Apple Mac device firmware. These malware infections are designed to exit independently of the operating system.



Some of the malware and their associated devices are listed:

- Sonic Screwdriver – Apple Thunderbolt-to-Ethernet Adapt firmware
- Dark Skies – Apple Macbook9k Air firmware (3 vectors below)
- DarkMatter – EFI Implant
- SeaPea – Kernel-Space Implant
- NightSkies – User-Space Implant
- Triton – MacOSX (2 vectors below)
- Dark Mallet – MacOSX Infector
- DerStarke – EFI-persistent
- NightSkies1.2 – Beacon/Loader/Implant Tool for the Apple iPhone

WikiLeaks notes that it is likely that many CIA physical access attacks have infected the supply chain. This means that that the malware infections are preloaded on devices and persist even if the operating system is re-installed. WikiLeaks later noted on March 26th that claims that "CIA hacking tools don't work on new Apple products" are false.

On March 31, 2017, WikiLeaks released *Marble Framework*, part 3 of the Vault 7 series. Included is 767 source code files for the CIA's anti-forensic operations.



These programs allow the CIA to mask their hacking operations and implicate other foreign powers in their hack attempts. Marble has examples in English, Chinese, Russian, Korean, Arabic, and Farsi.

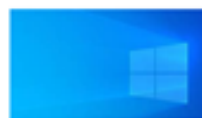
The marble Framework source code provides both the "obfuscators" as well as the "deobfuscators." This will allow forensic investigators to look back at previous attack signatures and determine if they were really the work of CIA with tracks covered using Marble.

VAULT 7 p.4 "Grasshopper"

WikiLeaks released *Grasshopper*, part 4 of the Vault 7 series on April 17, 2017. This release focuses on the persistent infection techniques developed by the CIA to target Microsoft Windows computers and devices. Included is 767 source code files for the CIA's anti-forensic operations.



The Grasshopper language allows CIA operators to quickly build complex, persistent, and custom spying loadouts. This allows the CIA to target specific operating systems, configurations, and to evade Protective Security Products (PSP) like Antivirus, MS Security Essentials, etc.

Over the past two months, WikiLeaks has released Year Zero, Dark Matter, Marble Framework, and now Grasshopper. From these releases we have learned that the CIA has virtually unlimited spying capacity – at home and abroad. Samsung, Apple, and Windows devices are being distributed with preloaded software that is often embedded onto firmware, re-installs itself, evades detection, and allows for remote control and data read/write. Moreover, all hacking attempts can be obscured – leaving the fingerprints of foreign governments.

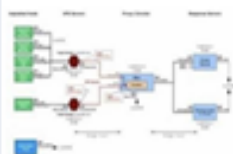

On Thursday, April 13, 2017, CIA Director Pompeo vowed to silence WikiLeaks and named them a "non-state hostile intelligence service." The following day, WikiLeaks released Part 5 of the Vault series, *Hive*.



Hive is the critical second piece to the implants described previously in the Vault 7 series. Where those implants are embedded onto targeted devices, Hive is actually located on the web – hidden on unsuspecting looking domains. This allows the CIA to communicate with target devices, executing commands or retrieving information.

Anti-Virus and forensic companies had suspected that state-actor malware could function in such a covert way, creating a back and forth between infected machines and "back-end" HTTPS, but could not attribute the traffic to the CIA. By analyzing the contents of Vault 7, Symantec has been able to attribute "Longhorn" to the CIA, which reveals that the IP addresses being used to conduct these attacks are owned by legitimate companies. This might explain Director Pompeo's new stance toward WikiLeaks.

WikiLeaks released both the documentation and source code for the CIA's *Scribbles* project on April 28, 2017. Scribbles is an offline document watermarking software that must be installed on a target's device. Once installed, Scribbles automatically embeds code onto Microsoft Office documents as they are accessed and modified. Using these watermarks, the CIA can identify insiders, whistleblowers, journalists, and others.

Obama DOJ Official Urges Durham Report 'Pause,' Claims Findings May 'Tarnish' FBI Officials

December 26, 2022—This excerpt from *Conservative Brief*.

An Obama-era spokesman for the U.S. Department of Justice claims that Special Counsel John Durham should not have the final say in his own investigation into alleged misconduct in the FBI's Trump-Russia investigation.

Matthew Miller, who served as the director of the department's public affairs office from 2009 to 2011, argued that Attorney General Merrick Garland, or another high-ranking official within the department, should review the report before it is shared with Americans.

"His cases are over. I think it's clear that he's not going to bring any more charges in this investigation, but one of the requirements for special counsels under the regulations is that they write a confidential report and submit it to the attorney general, and the attorney general then makes a decision whether to release that report to the public. I think Merrick Garland will be under a lot of pressure from Republicans to release that report, but I have to say, this circumstance is very different from the Mueller investigation, where, obviously, the attorney general, Bill Barr, did release that report," Miller said.

"It's different because in that case, the subject of that investigation could not be charged, and so it was appropriate for the department to make its findings public, so Congress could decide whether to impeach and convict the then-sitting president," he continued. "That is not the case here, so to release a report in this instance — given what we know about the way that Durham has behaved, some of his inappropriate public statements during this investigation, the poor judgments he has made in bringing these charges — to release a report publicly and let him have the final word I think probably unfairly tarnish some people at the FBI that we know he holds ill will to based on some of the things he said in this most recent trial."

"John Durham, the special counsel investigating potential misconduct in the Trump-Russia probe, has spent at least \$6.5 million on his inquiry, including \$2 million this year, according to financial documents released Friday by the Justice Department. The topline \$6.5 million figure captures Durham's spending between October 2020 and

September 2022. However, Durham started his inquiry in early 2019, and the cost of his first year and a half of the work has not been disclosed. That's because he was working at that time as a US attorney and was only appointed as a special counsel in October 2020," CNN reported.

In Major Step, Space Force Takes Over All Military Satellite Communications

COLORADO SPRINGS, Colo. 12 Dec 2022— The Space Force has taken over all of the Department of Defense's military satellite communication functions, a major step in building the new service.

The Navy and the Army have transferred major satellite communication operations to the Space Force in an effort to consolidate training, operations, acquisition and other activities, according to a news release. The transfer marks the first time all military satellite communication functions have been consolidated under a single military service.

The Army's transfers were expected to include \$78 million in operations, maintenance and 500 positions, the release said. As part of the consolidation, the Army transferred the Wideband Global SATCOM and Defense Satellite Communications System to the Space Force in August. The Wideband Global SATCOM system is considered the "backbone of the U.S. military's global satellite communications," according to the Space Force.

The Colorado Springs area did not see a net gain in jobs although some people did transfer from Fort Carson to Schriever Space Force Base, said Col. David Pheasant, commander of Delta 8. His delta focuses on satellite communications as well as position, navigation and timing, and represents about 10% of the Space Force.

As part of the overall consolidation, Pheasant said

he expects those trained in space operations will be able to spend their entire career working on space missions.

"They can build on that knowledge and be able to share it with others," he said.

Previously, a soldier in the Army might spend just a few years working as a satellite operator before moving on to a new job, he said.

The transfer of all new Space Force members as part of the consolidation is still underway and is expected to last through December, he said. However, those people are already working for the Space Force, even though they may still officially be members of other military branches.

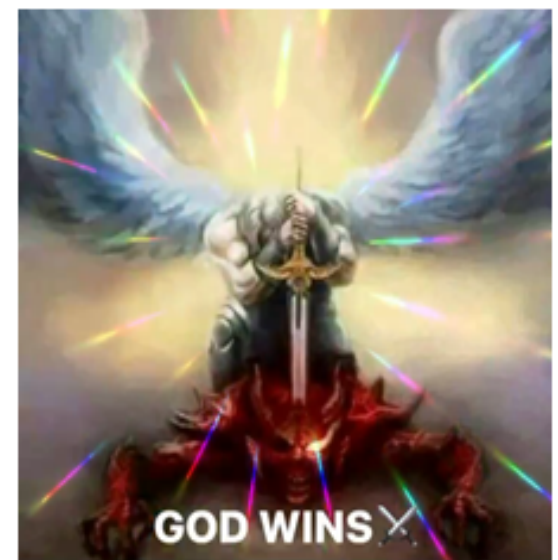
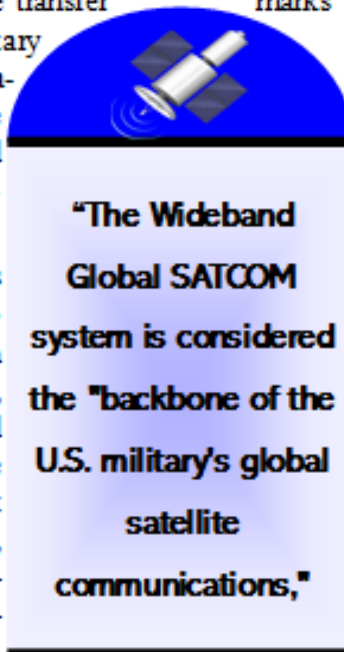
As part of growing Space Force capabilities, Pheasant said he expects the service to grow its partnerships with other countries.

For example, the service could put payloads on some of Denmark's satellites, he said.

Expanding capability in space is important because the military is seeing demand for satellite connectivity in the field proliferate, just as demand for data connections has risen in homes. Any resident likely has five devices or more in their home requiring a connection. Similarly one military vehicle in the field likely has five different pieces of equipment that need satellite connectivity.

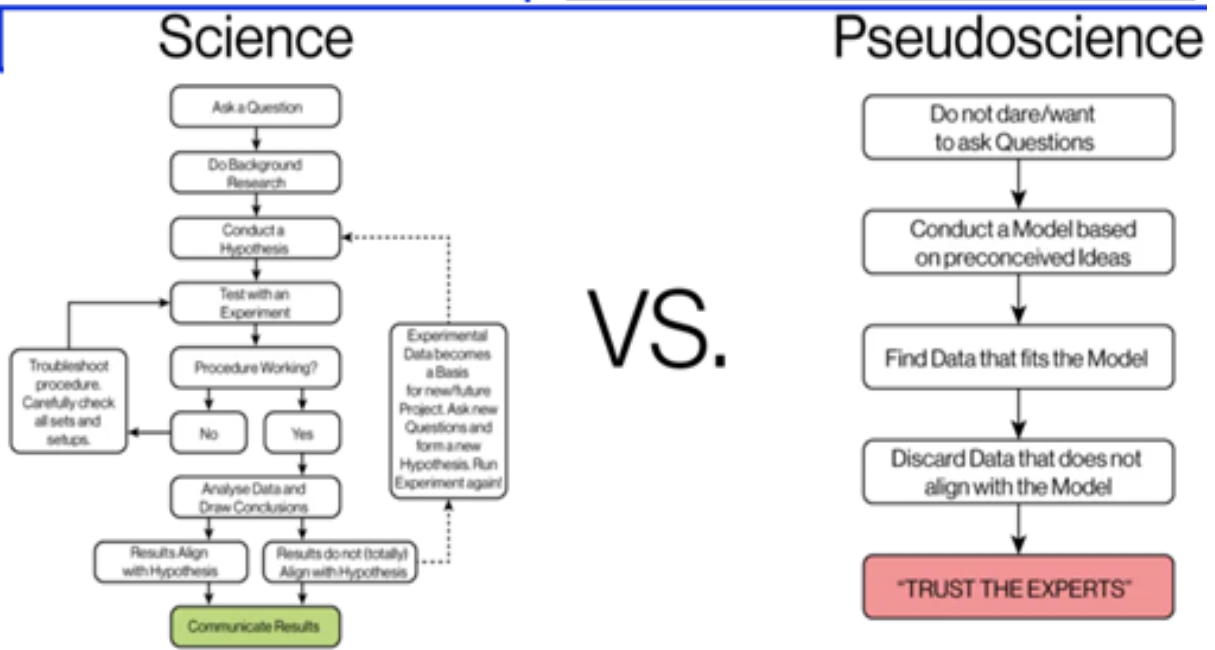

U.S. Moving Bioweapons Research

24 Dec 2022—Unfinished projects are being relocated to Central Asian and Eastern European countries, according to the Russian military

Washington has been moving its bioweapons research out of Ukraine, the head of Russia's Nuclear Biological and Chemical Defense Troops has claimed. This comes after the research laboratories' existence was exposed under the Trump presidency.

"The Pentagon is actively working to transfer its unfinished research projects to the countries in Central Asia and Eastern Europe," Igor Kirillov insisted during a briefing on Saturday.

The US has also been boosting cooperation with Cambodia, Singapore, Thailand, Kenya and other nations in the Indo-Pacific and Africa, with "the US Department of Defense being most interested in countries that already possess laboratories with a high level of bio-containment," he added.

According to the commander, data on illegal, US-backed laboratories in Ukraine was presented at the Organization for the Prohibition of Chemical Weapons conference, which took place in Geneva between November 28 and December 16.

It included "documentary evidence that work with components of biological weapons and studies of pathogens of especially dangerous and economically significant infections had been carried out on the territory of Ukraine with financial, scientific, technical and personnel support of the US," he noted.

Papers obtained by Russia during its military operation in Ukraine reveal that "military-biological programs" were run through the Mechnikov Anti-Plague Research Institute in Kiev, the Institute of Veterinary Medicine in Kharkov and the Lviv-based Research Institute of Epidemiology and Hygiene, Kirillov claimed.

The files also mentioned three Pentagon contrac-

tors and seven high-ranking officials of the US Department of Defense, he added.

The full text of a report by the US Defense Threat Reduction Agency (DTRA) on its work in Ukraine, seen by the Russian military, contained data, "confirming the conduct of exercises and training activities with pathogens of especially dangerous infections" in Ukraine, Kirillov said. When the Pentagon released this report to the public, 80% of its content had been redacted, he pointed out.

According to the Russian commander, the head of the American delegation at the conference declined to respond to Russia's accusations of violations of the Chemical Weapons Convention (CWC) by his country.

"Such a stance by the US and its blocking of any initiatives to resume work on the verification mechanism of the CWC once again confirms that Washington has something to hide, and that ensuring transparency in terms of compliance with the convention doesn't play into the hands of the Americans," he said.

However, the report by Russia didn't go unnoticed by other countries and "made many member-states reflect on the risks posed by cooperation with Washington in the military-biological area," Kirillov stressed.

The Russian military has been gradually releasing materials on the work of the US-backed biolabs in Ukraine since March. Washington has denied Moscow's bioweapons claims, calling them disinformation and a conspiracy theory used by Russia to justify its military operation.

UN Security Council votes against probe into US biolabs

03 Nov 2022—The US, France, and Britain shut down Russia's call to investigate "military-biological" activities in Ukraine

The UN Security Council has rejected Russia's call

for an international investigation into claims that the US used laboratories in Ukraine to develop biological weapons.

While China backed Russia's proposal, the US, Britain, and France voted against it, and the ten rotating council members abstained.

Russia insists that the US and Ukraine have been violating the 1972 international convention that bans the development, production, and stockpiling of biological weapons. According to Moscow, several laboratories in Ukraine were working on a secret "military-biological" program, which involved studies and the stockpiling of samples of anthrax, cholera, and other infectious diseases.

Washington and Kiev both deny developing biological weapons. Ukrainian President Vladimir Zelensky said in March that the laboratories were conducting "ordinary scientific research."

Thomas-Greenfield reiterated that the activities under the Pentagon's Cooperative Threat Reduction (CTR) program in Ukraine and other former Soviet states "are not for military purposes."

The US Mission to International Organizations in Geneva, Switzerland said in April that the CTR's goal in Ukraine was to help the country "consolidate and secure pathogens and to continue to ensure Ukraine can detect and report disease outbreaks before they pose security or stability threats."

Russian President Vladimir Putin on Wednesday accused the United States of pushing Ukraine to transfer hostilities to the Russian territory.

They're Coming for Our Children

CDC quietly confirms at least 118k Children & Young Adults have 'Died Suddenly' in the USA

Official figures quietly published by the U.S. Centers for Disease Control (CDC) confirm nearly half a million children and young adults have died ever since the Food & Drug Administration first granted emergency use authorization to a Covid-19 vaccine in the USA.

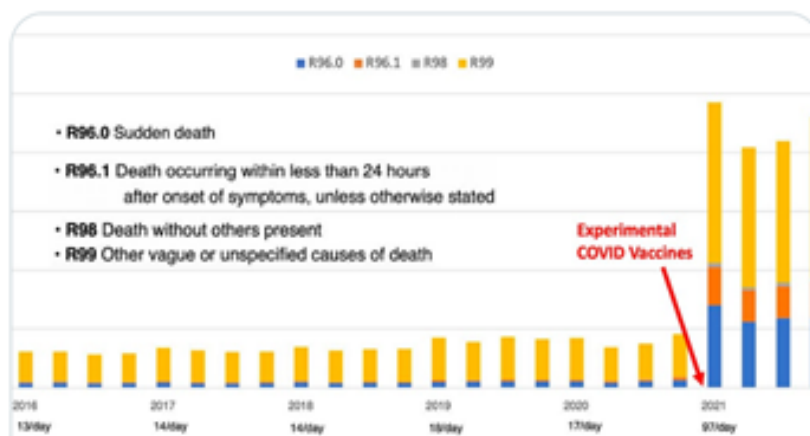
