The FBI Raids Mar-a-Lago, and I Have Questions

On August 8, 2022, the FBI raided Mar-a-Lago, President Donald Trump's Florida residence. Such an act against any president, past or present, has never been done before. The FBI served their warrant, searched the Trump family home, and even pried his safe open. They found...nothing. Not even Ashley Biden's lost diary.

What was Donald Trump's supposed crime that justified such an extreme measure?

Bribery? Nope, that's a Biden thing.

Treason? Nope.

Assault (perhaps on a Secret Service agent)? Nope.

Espionage? Nope, that's a Swalwell thing.

Cutting the tags off pillows? Nope.

The feds were looking for classified documents from when Trump occupied the Oval Office, which should have been turned over to the National Archives. Those would be the same documents that have already been declassified and that the Trump people are currently reviewing with the Na-

tional Archive people to figure out if they should be returned or not.

The Clinton administration provides a good point of comparison. Bill Clinton's former national security adviser, Sandy Berger, smuggled documents out of the National Archives in his pants and then destroyed them. It is believed that the documents would have embarrassed President Clinton during the 9/11 investigation. Was Berger's home searched? Nope. Did he go to jail? Nope, he was sentenced to...community service. Does anybody think Merrick Garland has community service in mind for Donald Trump?

An FBI application for a search warrant requires an affidavit from an agent swearing under oath to the need and circumstances for a warrant. According to Alan Dershowitz, to get a warrant, there should be no less intrusive means to obtain the evidence — like asking for it from a subject who is already cooperating with the investigation. Alternatively, there could be an immediate danger of evidence being destroyed — while being reviewed by other federal employees. Sure. But when working with a magistrate who was formerly employed by Jeffery Epstein, the FBI may have ways to get around those little formalities.

In other words, there was no rational reason to execute a search warrant on Trump's home. This also means that the FBI most certainly lied on the affidavit for the warrant — as they have a history of doing. Kevin Clinesmith has forever tainted the FBI's credibility on such matters.

I suspect that when the search warrant is reviewed by congressional investigators — and it will be — we will see proof of what we already suspect. The raid was an outrageous act, by a rogue federal agency, in service to a corrupt administration.

Putting aside the legality of the whole thing, I have a bunch of questions.

- Did President "Return to Normalcy" approve this, or is America now run by a shadow government? Biden claims he didn't know about the raid. If true, that's even scarier than the raid.
- Has Merrick Garland erased any doubt that the Deep State is a genuine threat to our republic?

- Is there any need for more evidence to fire Chris Wray and impeach Merrick Garland?

- Is it just a coincidence that Director Wray cut his Senate testimony short, and skedaddled out of Washington just days before the raid? Might he have been worried about a leak concerning the raid while he was still seated before Senator Grassley?
- Do we have enough now to at least start talking seriously about disbanding the FBI?

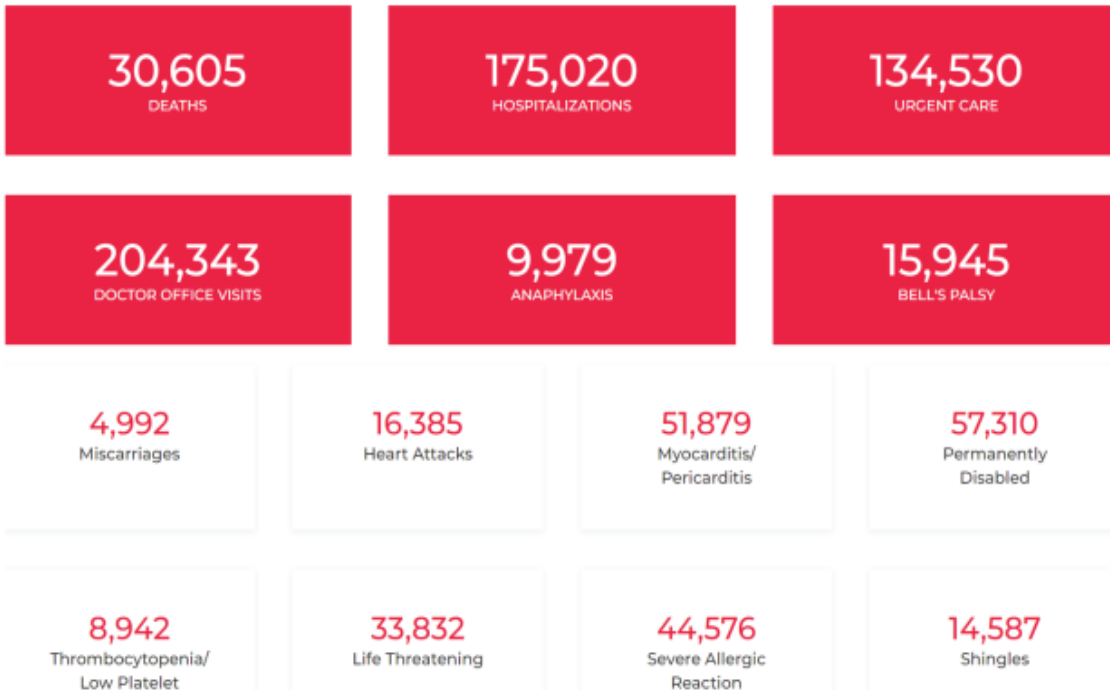

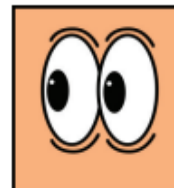

Father Whose Son Developed Myocarditis Following COVID-19 Jab Gets Pharmacist to Admit They're Hiding Potential Side Effects

A father spoke to a pharmacist on the phone after his 7-year-old son was diagnosed with myocarditis caused by the experimental COVID-19 shot.

The pharmacist responded by attempting to explain it's a 'rare' side effect.

"So, why are you not telling parents this?" he asked.

Father: Are you a pharmacist?

Pharmacist: Yes, how can I help?

not very happy with you guys or with my wife. She told me that she was not told that was a poten-

tial side effect. So why wouldn't you have told her that?

Pharmacist: Okay — sorry. So it's quite a rare side effect as well.

Father: No, it's not. No, it's not because I've been doing research; it's common. In the US, there's tens of thousands of them [myocarditis cases] reported to the CDC site. So why are you not telling parents this?

Pharmacist: We might scare the parents, and they don't want to get their child vaccinated.

Father: So you don't want to scare the parents with something that is actually happening, that's happened to my kid? Are you out of your mind? Are you out of your mind? You don't want to scare them? You need to give them the right information so they can make a proper decision! What is wrong with you? You don't want to scare them. I'm recording this conversation as well, and this is going to a lawyer next. Thank you for admitting that. So why don't you tell them? When someone comes in there and says, "Hey, what can go wrong?" What do you say? "Sore arm"? Have you seen the amount of dead people? Have you seen it?

Pharmacist: Has your wife asked before giving consent to give [the child the shot]?

Father: She asked what the side effects are!

Pharmacist: She asked? I'm not sure because I wasn't there.

Father: It doesn't matter! You're supposed to tell people this can happen. So you know what the prognosis is? You know what it is? Possible death within five years. 20% of people with myocarditis die! It is a permanent, damaged heart. It is not temporary! He's facing a heart transplant because of you! Because you didn't want to scare her! You know no kids have died from COVID, not a single healthy kid, and you're giving this stuff out, and you're not warning people? What is wrong with you?

Pharmacist: So there are information online that you can look up —

Father: No! No! You gave the shot. When someone comes in there and asks what the side effects are, you don't NOT say because it might scare them from the shot. What is wrong with you?

Pharmacist: So the benefit of getting a vaccination is — solely giving a vaccination because the benefits outweigh the risks.

Father: No, it isn't! Do you know I'm looking at a Johns Hopkins study? There have been 400 people under 18 die in the United States. 330 million people. Not one of them was healthy. They had cancer, leukemia, obesity, something wrong with them. Not one kid has died or ended up in the hospital. So the benefits are ZERO to my kid! Why did you not tell them? It's up to you to tell them. Then we make a decision. Not you! You tell us, "Okay, it's rare, but it happens. You didn't tell her that, did you?"

Pharmacist: I'm not sure. I wasn't the vaccinator

Father: You said you're not doing it. So when the next kid walks in there with a mother for a shot, are you going to tell them, "Hey, I just got a call from someone; their kid's heart is destroyed. Keep that in mind; that can happen." Are you going to tell them that? Are you?

Pharmacist: I cannot answer you that.

Father: Well, why can't you because it's going to go in a court, and you'll answer it. You just admitted that you don't tell people because you don't want to scare them. It's recorded; I've recorded everything.

Pharmacist: Sorry, I wasn't the pharmacist that did the vaccination.

Father: It doesn't matter; you just said it! You just said that you don't tell people.

Pharmacist: I don't know what the situation is, so I don't know what she told in the vaccination error. I'm not sure. I cannot speak on behalf of the pharmacist that vaccinated.

Father: You just told me you don't tell people because you might scare them. I have it on a recording. You want me to play it back? Every call — because I'm in finance — every call is recorded. Every email I sent is recorded. Every message I sent must be recorded because I work out of New York, and I live in New Zealand. It's all recorded because the SFC requires it. You are recorded. Father: No, we should because are you going to tell people this is a risk when they come through there? My kid's screwed! You screwed him. What about everyone else? What are you going to do? You ruined a life! It's on you for the rest of your life. This kid is screwed because of you because your policy there is to not tell people that these vaccines are dangerous and deadly. Father: It isn't? So you're just going to tell people, “Oh, nothing can go wrong,” and more kids are going to end up in the hospital with ruined hearts, right? That's the plan? Because you can't make that decision. And you'd hate for them not to take the shot, eh? Because then you don't get your 50 bucks, do you?

Pharmacist: So we always ask consent for the parent before we do the vaccinations.

Father: Yeah, but you don't tell them what can go wrong! Of course, you asked consent. The parent came there with that kid. It's obvious consent. Why are you not telling them what can go wrong? I'm sure they're asking. But you're like, “Oh, no. Nothing goes wrong. Just a sore shoulder.” Right? You don't tell them that the crazy guy called you and said his kid's life is ruined because of what you did a few days ago. Do you or will you? You are sick! You are sick! You are twisted. You are evil. You're a monster.

The Khazarian Mafia invades England after being expelled for hundreds of years:

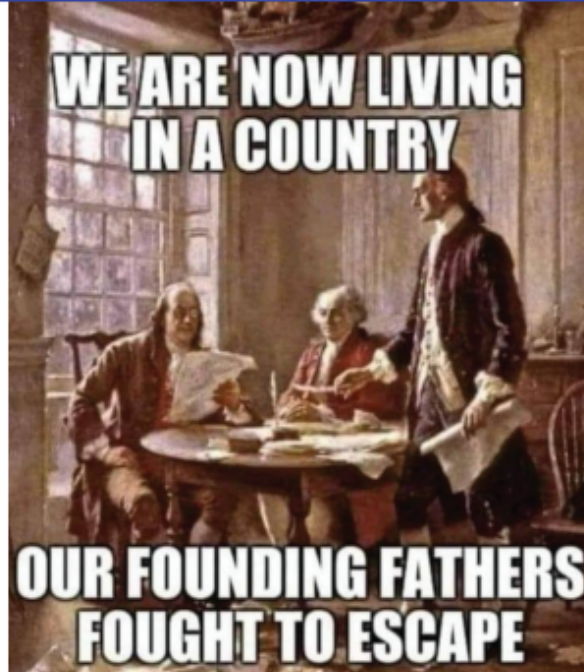

Here is where history becomes instructive regarding the Legislative Body of the State.

When the Tsar abdicated, the Russian Provisional Government was formed. Its purpose was to organize the free elections for the Russian Constituent Assembly. The provisional government lasted only eight months and was replaced by the Bolsheviks. A significant footnote to this period is that the Provisional Government was unable to make decisive policy decisions due to political factionalism and a breakdown of state structures. The anarchy fomented by Lenin and the Bolsheviks rendered a civil governing impossible. Whatever legislative bills were presented were instantly killed by opposition. Revolutionary unrest fueled violence. This was a deliberate design of non-cooperation and pure resistance! The General Election of 2020 spotlights the tragic devolving of the status of the U.S. Supreme Court. It is suggested by some, with validity, that the Supreme Court is no longer focused upon apolitical justice but has assumed an active role in establishing law that the U.S. Constitution reserves only for the Legislative Branch.

The Democrats/Progressives/Liberals have announced their intent to “pack” the Supreme Court with Justices who disrespect the U.S. Constitution. They want a left-leaning Court that will sanction the total dismemberment of the constitutional statutes that made America a great nation. The far-left Daily Kos **cautioned** Republicans that a “future government controlled by Democrats is likely to pursue — court-packing — as the best way to rebuff a conservative Court majority viewed as illegitimate.” Democrat Alexandria Ocasio-Cortez told voters during an October 2018 campaign event that Democrats **should** “pack the Supreme Court of the United States of America” after taking the House, Senate, and Presidency. Leading Democrats also warned that if the justices issue a pro-Second Amendment ruling, *and if Democrats win the White House and the Senate in 2020, then they will fundamentally remake the High Court.*

Former President Franklin Roosevelt issued this same threat in the 1930s after facing legal obstacles with his New Deal and subsequently “threatened to expand the Court by six seats for a new total of 15 justices so that he could get the rulings he wanted.” The American people, however, rejected his threat, leading to massive Republican victories in the 1938 midterm elections.

Former Democrat presidential candidates Senators Elizabeth Warren (D-MA), Kirsten Gillibrand (D-NY), and now vice-presidential candidate Senator Kamala Harris (D-CA) announced that they were open to reshaping the court. **“We are on the verge of a crisis of confidence in the Supreme Court,” Harris said, according to Politico. “We have to take this challenge head on, and everything is on the table to do that.”**

During the summer of 2020 several major progressive groups, including Take Back The Court, Demand Justice, Progressive Change Institute, and the Sunrise Movement, signed a letter declaring their support for increasing the number of justices by “at least” two seats. The resistance wrote in part: “The fastest, most effective way to make the court representative of all Americans is to enact legislation increasing the size of the Court by at least two seats, and to quickly fill those seats with justices who will

safeguard our democracy.” **Note: In the context of this reference it is best to remember Lenin’s manipulative ploy that his “free” election would best represent “all Russians”?**

In March 2019, President Trump astutely dismissed mounting calls from his Democratic opponents to pack the Supreme Court. “The only reason they’re doing that is they want to try and catch up, so if they can’t catch up through the ballot box by winning an election, they want to try doing it in a different way,” he added.

The late **Justice Ginsburg** balked at the proposition of packing the Supreme Court. **“It would make the Court look partisan,”** the late justice told National Public Radio’s Nina Totenberg last year.

The Judicial Branch of the government is to interpret laws respecting the United States Constitution’s limits. Once this unbiased governing is compromised, there is no lawful regulations for civility in our nation.

Concluding Thoughts...

This is where the United States of America is positioned as the General Election of November 2020 nears. A discord and division prevail that has never existed. This violence has been stoked with bitterness. The Progressives/Democratic Party/BLM/ANTIFA assure us that regardless of the election there will be violence. We are being conditioned to think that electoral results will take weeks or months to be validated and even then, they will be challenged. The vitriol marking the battleground is undeniable. The money the Rothschilds gained from the sale of opium was so vast that they became even more addicted to the easy money than the opiate addicts were to the opium.

The Rothschilds were the funding source behind the establishment of the American Colonies, by incorporating the Hudson Bay Company and other trading companies to exploit the New World of the Americas. The Rothschild KM then create an illegal taxation System in America:

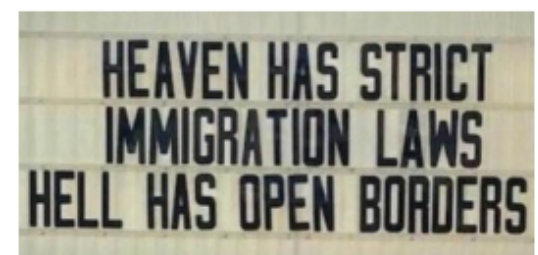

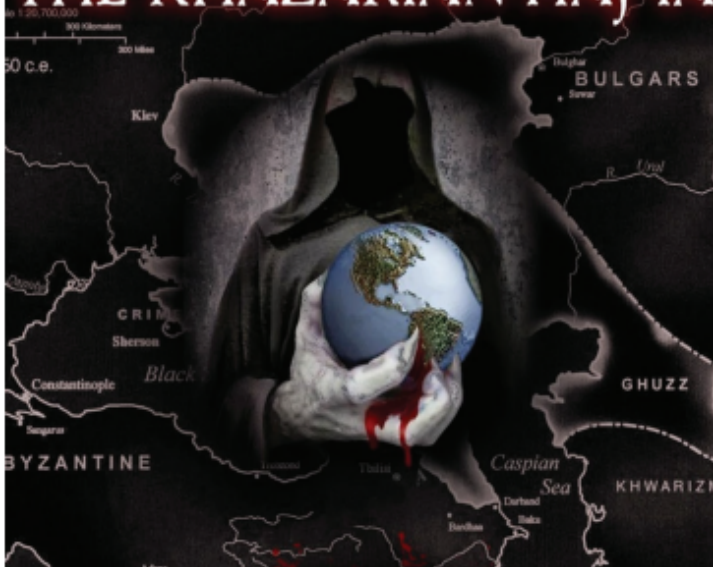

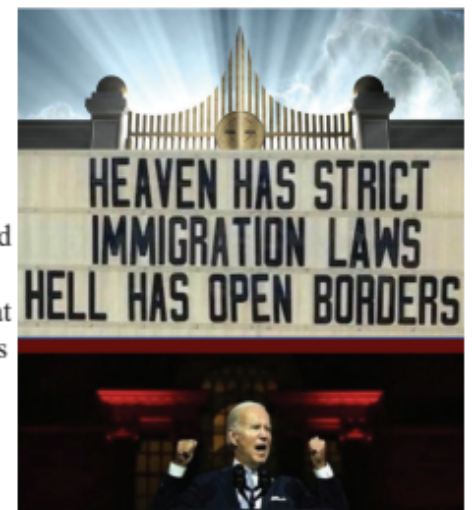
