WE WERE WRONG! "Puberty Blockers are Neither Safe Nor Reversible"

Dr. Susan Bradley, who helped pioneer "gender affirming care" in Canada, has now spoken against the popular model of "gender affirming care" by placing children on puberty blockers, according to an interview with the Daily Caller.

Dr. Bradley founded the Child and Adolescent Gender Identity clinic in Toronto, Canada in 1975 began to issue puberty blockers to children around the early 2000s. Prior to the medication, she used more traditional forms of therapy such as talking with her patients. In her interview with the Daily Caller, Dr. Bradley stated in regards to the puberty blocker medication:

"We were wrong. They're not as reversible as we always thought, and they have longer term effects on kids'

growth and development, including making them sterile and quite a number of things affecting their bone growth.

We thought that it was relatively safe, and endocrinologists said they're reversible, and that we didn't have to worry about it. I had this skepticism in the back of my mind all the time that maybe we were actually colluding and not helping them. And I think that's proven correct in that, once these kids get started at any age on puberty blockers, nearly all of them continue to want to go to cross sex hormones."

Despite the recent push to "affirm" children's gender identity by use of puberty blockers, the safety of such drugs is relatively unknown. According to the Doernbecher Children's Hospital: The U.S. Food and Drug Administration approved puberty blockers in 1993. They were originally approved to temporarily stop puberty in children who were going through it too early.

Researchers have not finished studying how safe puberty blockers are in the long term. So, there might be some risks that doctors do not yet know about.

Dr. Bradley participated in the "largest sample to date of boys clinic-referred for gender dysphoria with regard to gender identity and sexual orientation" with the most recent follow-up in

March 2021. The study found that 87% of male participants assessed at a mean age of 20.58 years were deemed "desisters." <as in cease and desist>

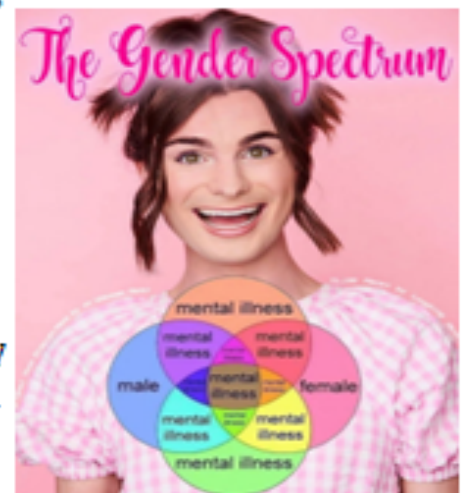
A parallel study of girls showed similar results: only 3 out of the 25 participants were judged to have gender-dysphoria at the mean age of 23.24 years.

In the interview, Dr. Bradley conceded: "These kids are not fairing well with the current affirmative approach. I don't know that

any kids actually could, given the capacity of a 10 or 12, or even 14 or 15 year old to understand the complexity of the decision that they're making on their long term sexual and life function. It just doesn't make sense."

“Blocking the sexual development of children is a highly authoritarian intervention. Children are asexual, and so they can’t understand the impact of impaired sexual function. We are roughly 10 years into this large-scale experiment and already we have reports on issues with cognitive development, bone mineral density, and fertility. All the up-to-date evidence shows that puberty blockers are neither safe nor reversible.”

Despite Dr. Bradley’s long term study suggesting that children eventually grow out of their gender dysphoria, there is still a widespread push to start children on puberty blockers at a young age. In the case of social media influencer Chloe Cole, 18, she was told that “gender dysphoria would never resolve itself” by doctors. The Gateway Pundit reported on a lawsuit filed by Harmeet Dhillon’s Dhillon Law Group and the Center for American Liberty on Cole’s behalf.

Chloe Cole (born 2004 or 2005) is an American activist who opposes access to gender-affirming care for minors and

UN report calls for decriminalization of all sexual activity, including between adults and children

A new report from the United Nations has called for all forms of drug use and sexual activity to be decriminalized globally.

Written by the International Committee of Jurists (ICJ), UNAIDS and the Office of the High Commissioner for Human Rights (OHCHR), the report was released on International Women’s Day, with the goal of guiding “the application of international human rights law to criminal law.” Called the “8 March principles,” the report calls for offenses re-

lated to “sex, drug use, HIV, sexual and reproductive health, homelessness and poverty” to be decriminalized.

The United Nations experts say that criminalizing offenses related to these issues constitute an attack on human rights.

“Criminal law is among the harshest of tools at the disposal of the State to exert control over individuals... as such, it ought to be a measure of last resort however, globally, there has been a growing trend towards over-criminalization,” Ian Seiderman, Law and Policy Director at ICJ, said in the press release. “We must acknowledge that these laws not only violate human rights, but the fundamental principles of criminal law themselves.”

While on the surface, it may seem relatively uncontroversial, the report calls for

sex between adults and minors to be decriminalized, so long as the minors “consent”:

With respect to the enforcement of criminal law, any prescribed minimum age of consent to sex must be applied in a non-discriminatory manner. Enforcement may not be linked to the sex/gender of participants or age of consent to marriage. Moreover, sexual conduct involving persons below the domestically prescribed minimum age of consent to sex may be consensual, in fact, if not in law. In this context, the enforcement of criminal law should reflect the rights and capacity of persons under 18 years of age to make decisions about engaging in consensual sexual conduct and their right to be heard in matters concerning them.

Pursuant to their evolving capacities and progressive autonomy, persons under 18 years of age should participate in decisions affecting them, with due regard to their age, maturity and best inter-

ests, and with specific attention to non-discrimination guarantees.

Minors, of course, cannot truly consent to sex with an adult —something these so-called experts should know. The report also calls for all criminal laws relating to sex work to be abolished, which could easily serve to aid traffickers, pimps, and abusers.

NPR 'social justice reporter' Falsifies Report by Withholding Key Facts

NPR shared an audio clip of a friend of the suspect who described the alleged cop shooter as “a peaceful, kind, vegan who liked to garden and would make soups from things that she grew in her garden.”

The “social justice reporter” for a Seattle NPR station attempted to garner sympathy for a trans Democratic Socialist of American member who was affiliated with Antifa that allegedly killed himself. However, the “reporter” failed to mention that the activist committed suicide after allegedly shooting a cop while being served an eviction notice.

On Monday, a King County Sheriff’s deputy was shot while serving an eviction notice in the Ballard neighborhood of Seattle. According to law enforcement, three deputies were serving the notice, but when they encountered the resident being evicted, there was a shootout. The three deputies opened fire and one deputy was shot in the upper torso above his bulletproof vest.

The deputy who was shot was identified as David Easterly and remains in critical condition at Harborview Medical Center’s ICU.

The Independent Force Investigation Team for King County on Tuesday identified the resident being evicted who was involved in the shooting as 29-year-old Eucytus, formerly Nathan Stolsig, a transgender woman. The King County Medical Examiner confirmed that Stolsig died from a self-inflicted gunshot wound.

IFIT-KC update regarding the March 20, 2023, deputy-involved shooting in Ballard.

King County Sheriff’s Department Officer-Involved Shooting

This update concerns the March 20, 2023, investigation into the King County Sheriff’s deputy-involved shooting in the 800 block of NW 54th St. in Ballard.

The Independent Force Investigation Team – King County (IFIT-KC) is serving as the independent investigative team for this OIS. IFIT-KC is a multi-agency team comprising investigators from 13 King County Police Departments. As this incident involved the King County Sheriff’s Department, all KCSO deputies and investigators have been excluded from this IFIT-KC investigation.

UPDATE: The resident who died in the deputy-involved shooting has been identified as 29-year-old Eucytus Eucytus. They are formerly known as Nathan Stolsig. The King County Medical Examiner conducted an autopsy today, and the Medical Examiner’s preliminary findings indicate Eucytus died from a single gunshot wound to the head. No other wounds or injuries were discovered during the autopsy. Detectives will continue to investigate and are sending the single recovered bullet to the lab for ballistics testing to identify the weapon it came from.

The King County Sheriff’s Department has updated the information regarding the involved deputies to include years of service and assignments. Det. Benjamin Wheeler, 25 years with KCSO, assigned to the Civil Process Unit. Det. Benjamin Miller, 23 years with KCSO, assigned to the Civil Process Unit and Det. David Easterly, wounded, 24 Years with KCSO, assigned to the Civil Process Unit. Since the detectives work in various roles with the King County Sheriff’s Office, including undercover assignments, the department will not be issuing photographs.

For condition reports on Detective Easterly, please contact Harborview.

While examining the scene overnight, investigators found evidence indicating all three deputies probably returned fire. Further ballistics testing will be done to help confirm this.

The IFIT-KC team is in contact with the family of the person involved in this incident and will be keeping them informed of the progress of the investigation. We are waiting for the King County Medical Examiner to positively identify the decedent and will release that information once it is confirmed.

Effective March 20, 2023, Meeghan Black will serve as the PIO for this IFIT-KC investigation.

Fowler then posted a link to suicide prevention resources. Later in the day, Fowler retweeted an article

from the Seattle Times entitled “Ballard eviction underscores process’s complexities.”

The social justice reporter was slammed on the platform for omitting the full details of the event, especially the alleged shooting of the deputy.

On Thursday night, Tucker Carlson called out the omission by the social justice reporter for the taxpayer funded NPR affiliate saying, “so obviously this country has reached peak frivolity.”

Historian Calls Pedophilia 'Intergenerational Sex'

Refuses To Describe Rape Of 10-Year-Old Boy As 'Abuse'.

Historian Rachel Hope Cleves described pedophilia as "intergenerational sex," adding that she wouldn't describe the abuse of children with words such as "survivors or necessarily abuse."

Cleves wrote an op-ed in the Washington Post earlier in March that argued against Republicans wanted to ban drag shows to reinforce "traditional hierarchies of race, class, sex and gender."

The resurfaced clip was part of a Zoom interview Cleves had with fellow author Alexis Coe in 2020, hosted by Chicago University Press.

"In writing this book I didn't want to use pedophilia discourse because I felt like it would fail to capture this other historical organizing system, for intergenerational sex, which was the topic I wanted to address," Cleves says in the video.

Cleves is a professor of History at the University of Victoria, according to

their website, but is currently on leave.

Cleves wrote a biography of British author Norman Douglas in 2020, who was charged multiple times with rape and sexual assault of underage boys and girls, including two cousins aged 10 and 12.

"I felt like that contemporary language would have made it impossible really for us to reckon with this prior historical system," Cleves continued in the video, discussing her book. "So I do talk about intergenerational sex, to get to this terminology question, this is a contentious term because by the standards of our time, we don't see any possibility for sex between adults and children, we see it as rape, and not following within the framework of sex and sexuality. I don't use the dis-

course of survivors or necessarily abuse to make sense of sources."

Cleves co-authored an opinion column in 2017 which argued that Republican Alabama Senate candidate Roy Moore, who was accused of sexually assaulting several underage girls, was "not a pedophile."

"Moore's alleged crime was not a sexual orientation toward children," Cleves and her co-author Prof. Nicholas L. Syrett said. "It was his willingness to exploit the unequal power structures of gender and age to victimize young girls who couldn't stand up to him."

CONVICTED CHILD RAPIST BEHIND SURROGACY EMPIRE NOW UNDER INVESTIGATION FOR BABY TRAFFICKING

A surrogacy empire owned by a convicted pedophile has come under investigation for arranging fictitious marriages, falsifying documents to smuggle babies out of Ukraine, and trading children for profit, according to a Paris-based consortium of investigators.

The Organized Crime and Corruption Reporting Project (OCCRP) has released an investigation which links Barcelona-based surrogacy company Subrogalia to a network of corporations controlled by two men, one of whom sexually abused the other as a child and has an extensive history of child rape.

José María Hill Prados, now 62, was 45 years old when he first met Didac Giménez Sánchez at the Casal Dels Infants del Raval center for minors in Barcelona. Prados exposed 12-year-old Sánchez to pornographic films in order to groom him at his home in Cervelló, Spain, where he also sexually assaulted the boy. In 2007, Prados was sentenced to eight

years in prison for sexually abusing both Sánchez and his sister on charges that included raping the children, and for creating illicit pornography of the acts he subjected them to.

However, the sentence was anonymized, with Prados' identity being obscured as 'Carlos Jesús' in court records and Sánchez being identified as 'Baltasar.' The following year, Sánchez desperately recanted his allegations, claiming he was pressured into making the accusations.

But the judge disagreed, having already heard the boy's testimony presented to the court, and found there was sufficient evidence to sustain the conviction. Prados would go on to serve his full prison sentence.

This was not the first instance of child sexual abuse committed by Prados. In 1996, he was investigated by a Barcelona court for the alleged crime of corruption of minors and several more sexual

assaults of which his four adopted children, aged between 12 and 17, were reported to be victims. Prados, then 36, was the founder of a Russia-based children's foster organization called Padres para Siempre (Parents forever), and the details of the case were sealed from the public.

Defense lawyer Jordi Rojo used Prados' children, those he abused, to argue against his imprisonment, and told the court that his client “loves his children very much and is very concerned about what could happen to them now.” The four minors, two brothers aged 17 and 16 and another two boys aged 13 and 12,

had been taken into the care of the Generalitat's Children's Department during the court proceedings.

On the day the children were expected to testify in court regarding the allegations, they suddenly backed down and denied that they had ever been sexually abused. As the children had not yet made a statement on the record, Prados could not be convicted.

Soon after Prados was released from prison for his 2007 conviction, he legally changed his name to Diego, and he and his former victim became business partners.

In 2015, Prados and Sánchez set up a surrogacy company called Subrogalia based in Spain, according to corporate records. The company, one of over a dozen currently owned by the two men, was quickly mired in controversy and allegations of child trafficking.

The probe into Prados' extensive criminal empire found that Subrogalia had been investigated in at least two countries out of the nine where it now operates. Alleged crimes include selling and trafficking of babies, in addition to providing clients with infants that were not biologically related to them.

In 2016, the year after the Spanish franchise of Subrogalia was founded, two gay couples sued the company for failing to deliver them sons as promised. A judge ordered the company to pay €88,000 (approx. \$95,000 USD) to the claimants for “serious and grave” breaches of contract.

Subrogalia has operations in as many as nine countries, including Russia, Greece, and, briefly, Mexico. But the primary source of the company's revenue can be traced to its clinics in Ukraine. The OCCRP investigation cites a former manager who said that, before the war, women in Ukraine bore approximately 100 babies annually for paying parents, each earning the company around €8,000 (approx. \$8,600 USD) in profit.

“Dídac [Sánchez] and José María [Prados] share an office. Prados calls himself Diego in the company, perhaps because it is the only name that appears in the Mercantile Registry. They arrive early, go to eat together and leave around eight in the evening. It is difficult to see them separated, they are like the same person”, a former Subrogalia employee told El Confidencial.

“The entire office knows the reality of the company: they know that Diego is not Diego, but José María, the Raval pedophile, and that Dídac is Diego, his victim, who only counts outside the gates. He is the pretty face of Hill Meadows for the press, because he knows that his children are too contaminated to come to light,” the source continued, adding that there is frequently an “unjustified presence of minors” at the company.

Whistleblowers at Subrogalia have told the press that Sánchez serves as the face of the company, despite being regarded as a “nobody at a business level.” Prados, it is said, is the “shadow boss” of the scheme. Prados’ adopted sons also similarly assist in business operations. Alan Hill Prados has worked as a surrogacy manager at Subrogalia, and Andrei, who is originally from Russia, acts as an intermediary in dealings between the clinic in his home country and the Barcelona location.

Before the escalation of the conflict in Ukraine, the Eastern European nation was known as an international hub for the sale of babies through surrogacy con-

tracts. The industry has been known to target women who are struggling financially, offering them payments of approximately \$11,000 for a healthy baby – more than three times the average yearly salary in Ukraine.

In order to distance the company from the litigation, Subrogalia Ukraine rebranded as Eurosurrogacy in 2017. Concurrently, Subrogalia Spain was renamed to Gestlife.

“More than 45% of our parents are single men, gay couples, or single gay men, who, at a certain point in their lives, have received the call of parenthood. Surrogacy for gay couples, or for single men, is the best way to achieve parenthood, due to the practical impossibility of a successful international adoption process. The number of surrogacy cases in Spain has, in the last two years, surpassed the number of international adoptions,” reads Gestlife’s website on a page aimed at “LGBT” customers.

Sánchez was also named as the founder of his own Ukrainian IVF clinic in 2017 named InterFiv. In 2021, one of Prados’ sons took over ownership, and that same year the clinic was raided by law enforcement for allegedly arranging fictitious marriages and falsifying documents in order to smuggle babies out of the country.

Prados and Sánchez were also business partners with one of the largest IVF clinic chains in the world, the BioTexCom Clinic in Kiev, which has implanted embryos for about 95 percent of Eurosurrogacy’s Spanish clients.

In 2018, Sergii Antonov, a Kiev-based lawyer specializing in the medical field, told the press that of the estimated 2,000 infants born through surrogacy in Ukraine every year, nearly half were through Bio Tex Com.

That same year, Ukrainian authorities opened an investigation into the compa-

ny. Employees were accused of being involved in a “criminal group” that used surrogacy programs as a cover for trafficking children. Prosecutors allege they helped “foreign citizens to make illegal deals, involving minors” that amounted to “trading children for a financial reward.”

Eurosurrogacy was implicated in the crimes and has had its bank accounts frozen as the probe into their illegal activities continues.

“It is absolutely appalling that a convicted sex offender should be allowed to operate in such a sensitive area as gestational surrogacy, which is based on exploitation of women living in poverty,” Nina Potarska, Ukrainian head of the Women’s International League for Peace and Freedom, told the OCCRP. “Given the background of such exploitation, it is not surprising that there are allegations of malpractice, such as trafficking of babies.”

BioTexCom told the press that its management was unaware of Prados’ criminal record when they went into business together. This claim is not entirely without merit: in addition to his surrogacy network, Prados is also the figure behind a shadowy corporation dedicated to burying and erasing incriminating information from the internet.



“We erase your past,” boasts Eliminalia, a business led by the convicted pedophile, which has earned millions in revenue over the past decade for restoring the online reputation of hundreds of clients who have been convicted and investigated in 54 countries for corruption, money laundering, sexual abuse and drug trafficking.

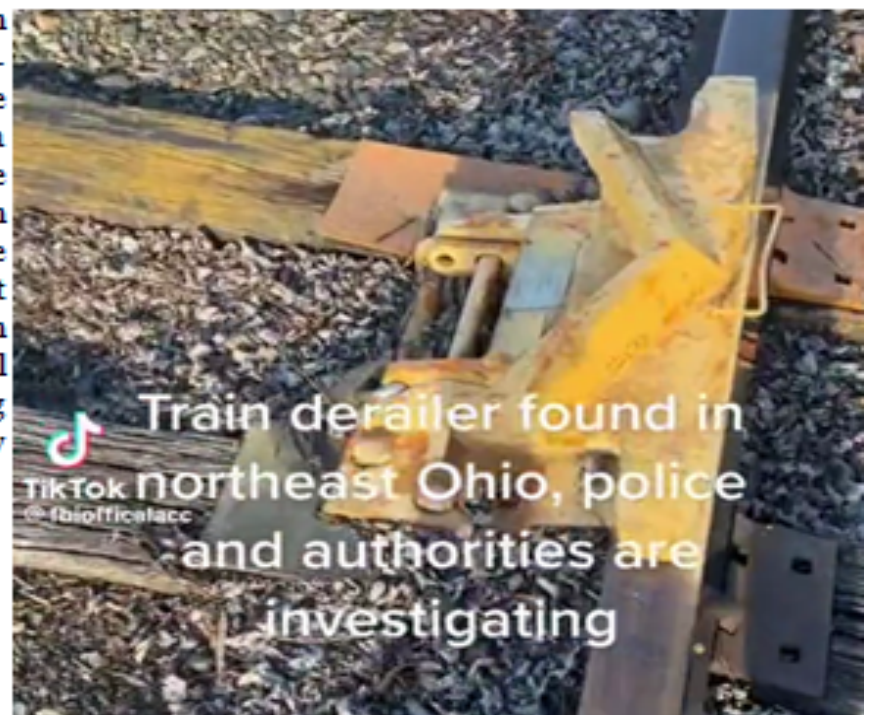

New Medical Codes for COVID-19 Vaccination Status Used to Track People, CDC Confirms

Medical codes introduced during the COVID-19 pandemic to show when people are unvaccinated or under vaccinated for COVID-19 are being used to track people, the top U.S. public health agency has confirmed.

The U.S. Centers for Disease Control and Prevention (CDC) made the confirmation in [emails](#) that The Epoch Times obtained through a Freedom of Information Act request.

The CDC had said in documents and public statements that the goal of [the new codes](#) in the International Classification of Diseases (ICD) system, was “to track people who are not immunized or only partially immunized.”

The CDC now says it doesn't have access to the data, but that health care systems do.

“The ICD codes were implemented in April 2022, however, the CDC does not have any data on the codes and does not track this information,” CDC officials said in the emails.

“The codes were created to enable healthcare providers to track within their practices.”

The emails were sent to news outlets. The CDC hasn't answered queries from The Epoch Times about the codes, which the CDC added to the U.S. ICD system in 2022.

How Providers Are Using the Codes

The CDC proposed the codes in 2021.

“There has been interest expressed in being able to track people who are not immunized or who are only partially immunized,” Dr. David Berglund, a CDC

medical officer, said during a meeting about the proposal.

One code is for being “unvaccinated for COVID-19.” Another is for being partially vaccinated or not having received a primary series of a COVID-19 vaccine.

In comments to the CDC about the proposal, health care providers said they supported adding the codes—with some detailing how they'd be used.

Identifying people who are unvaccinated or under vaccinated for COVID-19 “will help health insurance providers identify emoltees [sic] who may benefit from outreach and further education about vaccination,” Danielle Lloyd, a senior vice president at America's Health Insurance Plans (AHIP), and Adam Myers, senior vice president at the Blue Cross Blue Shield Association, said in a joint letter to the CDC.

Creating ICD-10 codes that can be tracked via claims would provide health insurance providers key information to help increase immunization rates.”

In another missive, Nancy Andersen, a director with Kaiser Permanente Health Plan and Hospitals, and Erica Eastham, executive director at The Permanente Federation LLC, told the CDC, “These codes provide valuable data for understanding immunization rates and for follow-up with under-immunized patients.”

Andersen and Eastham urged the CDC to advise providers entering one of the new codes to also enter an additional code indicating why a person was unvaccinated or under vaccinated, with reasons including contraindications and “belief or group pressure.”

The comments were obtained by The Epoch Times through a Freedom of Information Act request.

Most of the providers and other health care groups that commented, including the American Health Information Management Association (AHIMA), didn't respond to inquiries.

AHIP declined to say what education it offered to people tracked through the new codes. A spokeswoman pointed to a Feb. 28, 2022, article that outlines steps providers have taken to promote vaccination.

The codes are part of the ICD's 10th edition. The World Health Organization of the United Nations holds the copyright for ICD-10 but has allowed the U.S. government to adopt the edition, according to the CDC. The new codes aren't part of the World Health Organization's ICD.

All health care entities covered by the Health Insurance Portability and Accountability Act must use the U.S. version of the ICD. The U.S. version is updated at least once a year. Coded ICD data from providers enable public health officials to "conduct many disease-related activities," according to the CDC. One of the purposes is to enable doctors seeing new patients to easily retrieve the patients' medical history.

Support

Health care officials largely said they supported adding the codes because being unvaccinated or under vaccinated was a "risk factor."

"AHIMA supported the new codes for under-immunization for COVID-19 status because being unvaccinated or partially vaccinated ... is a health risk factor, increasing the individual's risk of morbidity and mortality," a spokeswoman for AHIMA told The Epoch Times via email.

"The ICD-10-CM coding system includes codes for many health risk factors, and being under-immunized for COVID-19 status represents

The ICD system was originally intended to classify diagnoses and reasons for visiting the doctor, not to conduct surveillance on the personal medical decisions of American citizens.

another type of risk factor. It is important to be able to identify factors influencing a patient's health status so that healthcare providers are aware of the person's increased risk."

Some experts have said there is no medical indication for the new codes because of the small risk most Americans face from COVID-19.

"I have a hard time clinically seeing the medical indication of using them," Dr. Todd Porter, a pediatrician, told The Epoch Times previously. "We do not do this for influenza, which in the younger age groups has a higher IFR [infection fatality ratio] than COVID-19. Using these codes also disregards the contribution of natural immunity, which research evidence shows is more robust than vaccine immunity."

CDC Refuses to Answer Members of Congress

The CDC, meanwhile, has refused to answer questions from members of Congress about the codes.

Rep. Chip Roy (R-Texas) and nine other members said they were concerned about the federal government apparently gathering data on the personal choices of Americans and said they believe the data serve "no sincere purpose in treating patients' medical conditions."

"The ICD system was originally intended to classify diagnoses and reasons for visiting the doctor, not to conduct surveillance on the personal medical decisions of American citizens. Given the profound uncertainty and distrust felt by many Americans toward the CDC and the medical apparatus at large, it is important for the CDC to make clear the intent and purpose of these new codes," the members said. They also asked what steps the CDC is taking to make sure Americans' private health information is protected.

The CDC hasn't replied to the Feb. 14 letter, members told The Epoch Times.

"I have asked five simple questions about the CDC's unprecedented tracking of why Americans declined the COVID-19 vaccine. The CDC has so far refused to answer these basic questions. The American people deserve answers on what data CDC is gathering on Americans and why," Roy told The Epoch Times in an emailed statement.

"The American people deserve to know what the CDC is doing with their personal data," Rep. Josh Brecheen (R-Okla.) said. "It has now been more than a month and a half, and the CDC still refuses to tell us why it is tracking Americans' reasons for not taking the COVID-19 vaccine. The CDC must be held accountable to the American taxpayer."

Minneapolis becomes first major American city to allow broadcast of five Muslim calls to prayer per day year-round

Minneapolis will allow broadcasts of the Muslim call to prayer at all hours, becoming the first major U.S. city to allow the announcement or 'adhan' to be heard over speakers five times a day, year-round.

The Minneapolis City Council unanimously agreed Thursday to amend the city's noise ordinance, which had prevented dawn and late evening calls at certain times of the year due to noise restrictions, the Minneapolis Star Tribune reported.

The vote came during the Muslim holy month of Ramadan. 'The Constitution doesn't sleep at night,' said Jaylani Hussein, executive director of the Minnesota chapter of the Council on American-Islamic Relations, after the vote.

He said the action in Minneapolis shows the world that a 'nation founded on freedom of religion makes good on its promise.'

Minneapolis has had a flourishing population of East African immigrants since at least the 1990s, and mosques now are common. Three of 13 members of the council, Aisha Chughtai, Jeremiah Ellison and Jamal Osman, identify as Muslim.

The decision drew no organized community opposition. Mayor Jacob Frey is expected to sign the measure next week.

'Minneapolis has become a city for all religions,' said Imam Mohammed Dukuly of Masjid An-Nur mosque in Minneapolis, who was among several Muslim leaders who witnessed the vote.

Three years ago, city officials worked

with the Dar Al-Hijrah mosque to allow the adhan to be broadcast outdoors five times daily during Ramadan.

Prayers are said when light appears at dawn, at noon, at mid- to late afternoon, at sunset and when the night sky appears.

In Minnesota, dawn arrives as early as before 5:30am in summer, while sunset at the solstice happens after 9pm.

The city allowed year-round broadcasts last year, but only between 7am and 10pm - typically excluding early morning prayer and sometimes night prayer.

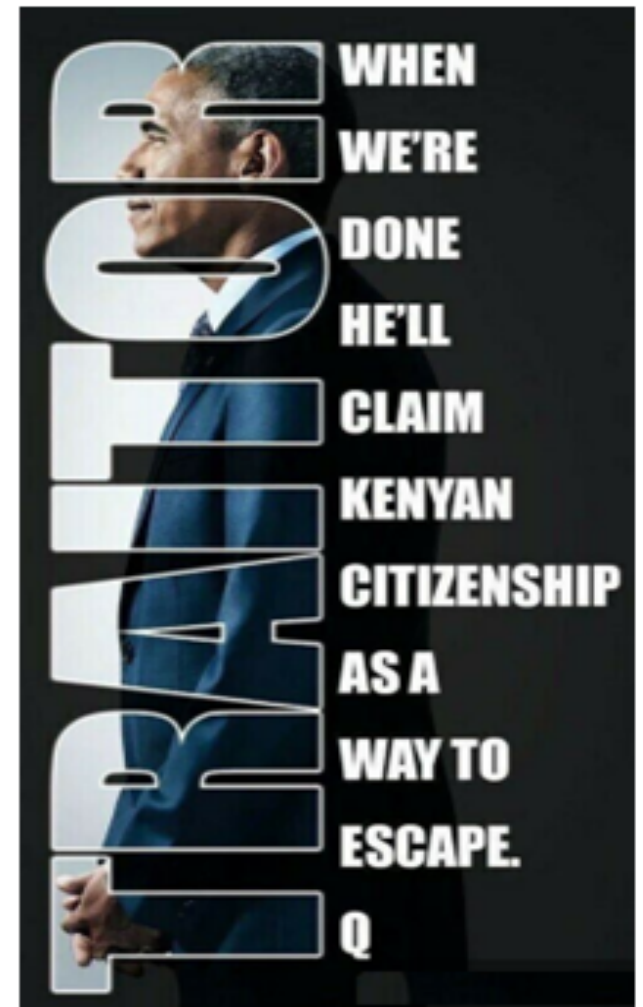
Ellison, Chughtai and Osman remarked that previous efforts to extend the adhan carried the feeling of asking permission, as opposed to exercising a right enjoyed by other religions.

At a recent public hearing, Christian and Jewish leaders expressed support for extending the hours for the adhan.

Council Member Lisa Goodman, who on Thursday was observing the final day of Passover, said the Jewish call to prayer - which is generally spoken rather than broadcast - doesn't face legal restrictions.

Observers said church bells regularly toll for Christians.

'It's something I grew up with, but not



my children,' council member Jamal Osman said, adding that hearing the call to

From transgendered to 'transabled': People are 'choosing' to identify as handicapped

A troubling societal issue called "transableism" is attracting attention these days.

Transableism is a newer term for BIID, or "Body Integrity Identity Disorder," in which a person actually "identifies" as handicapped.

BIID has been relabeled to transableism to align with today's trans community, according to some.

The point of "changing the identifier" from a psychiatric condition (BIID) to an advocacy term (transableism) is to "harness the stunning cultural power of gender ideology" to the cause of allowing doctors to "treat" BIID patients by "amputating healthy limbs, snipping spinal cords or destroying eyesight," according to Evolution News and Science Today (EN), which reports on and analyzes evolution, neuroscience, bioethics, intelligent design and other science-related issues.

Culturally, transableism is "the next abyss," that site also notes.

Why? Because "some of these persons mutilate themselves; others ask surgeons for an amputation or for the transection of their spinal cord," that site adds of the shocking steps some are taking.

The National Institutes of Health (NIH) notes on its website, "Those with BIID desire the amputation of one or more healthy limbs or desire a paralysis."

A North Carolina college student called transableism a "cry for attention."

The 24-year-old told Fox News Digital, "It's offensive to people who actually suffer from the condition that you say you need, in order to be your true self."

He went on, "It's embarrassing, and I don't know if you can be considered a serious human being if you alter your body like this, instead of getting the appropriate mental help you need."

In one case of BIID, Jorund Viktoria Alme, 53, a senior credit analyst in Oslo, Norway, identifies as disabled and uses a wheelchair, even though she has no physical handicap.

Alme is also transgender, according to HeraldScotland.com. Alme said on the morning TV program "Good Morning Norway" in 2022 that it had been a

"lifelong wish" to have been born "a woman paralyzed from the waist down," the same source noted.

In an even more shocking case, a 21-year-old North Carolina woman who identified as blind actually took steps to destroy her own eyesight, according to multiple reports from a few years ago.

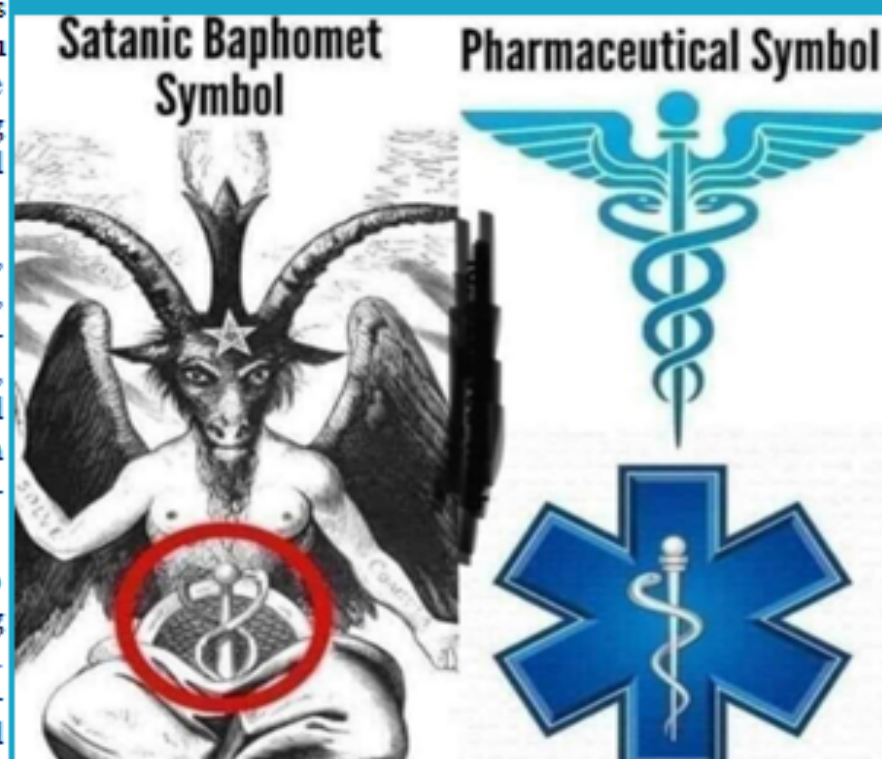
One Arizona internist called today's transableism a "delusional disorder."

"In my opinion, both transgender and transabled persons suffer from a delusional disorder," Jane Orient, a general internist in Tucson, Arizona, and executive director of the Association of American Physicians and Surgeons, told Fox News Digital via email.

"The Oath of Hippocrates adjures physicians to do no harm," Orient said.

"Mutilating the body is an objective harm even if makes the pa-

tient subjectively feel better," she added.

"The disability is lifelong and imposes burdens on others — and neither patients nor physicians can duck responsibility for that."

Orient also noted, "With transgenders the follow-up is generally very short — not sure about the [follow-up with] elective amputees," she said.

"The 'no other way' [to cope with the condition] excuse is a cop out; we need to find other ways," she also said. "Denial of reality is anti-scientific."

Dr. Marc Siegel, a clinical professor of medicine and a practicing internist at NYU Langone Medical Center in New York City — as well as a Fox News medical contributor — told Fox News Digital via email that most doctors will "only perform procedures they feel are medically indicated."

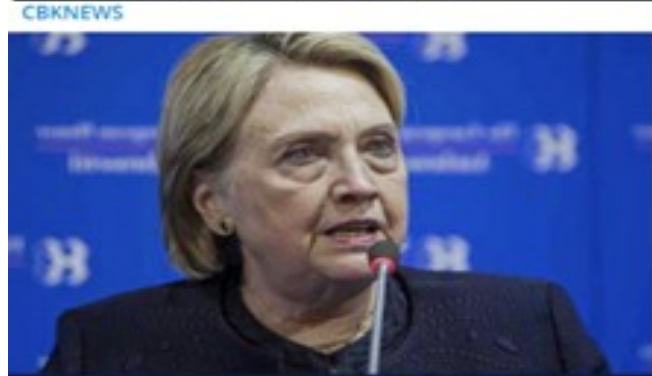

Eligibility

The COVID-19 Vaccine Provider Incentive program is open to you if you are a participating Kentucky primary care provider with an Anthem Blue Cross and Blue Shield Medicaid (Anthem) panel size of 25 or more members. All Anthem members identified as receiving COVID-19 vaccination services are included in the methodology. Vaccine results will be determined by a COVID-19 vaccine claim or by confirmation from the Kentucky Vaccine Registry.

The results will be calculated for two time periods:

- September 1, 2021 – Initial incentive payment
- December 31, 2021 – Final incentive payment

How you can qualify for a bonus

If your practice meets the below thresholds for vaccination with at least one dose by September 1, 2021, you will receive the initial incentive payment based on the following rates:

- 30% Anthem members vaccinated – \$20 bonus per vaccinated member
- 40% Anthem members vaccinated – \$45 bonus per vaccinated member
- 50% Anthem members vaccinated – \$70 bonus per vaccinated member
- 60% Anthem members vaccinated – \$100 bonus per vaccinated member
