Good evening to the St. Thomas More Society, your guests and other dignitaries who are present. I want to thank you for the honor of having me address you tonight.

St. Thomas More walked a narrow road that led to a fulfilled life. He described this and other principles that somehow found their way into our very own Constitution. In a letter before his execution in 1535, he wrote of life, liberty and friendship, and as he described, "the winning of Christ," he was describing an eternal pursuit of happiness.

Trying to determine what to speak about this evening, I have chosen to speak about evil and the evils of communism. What it means, where we are and what it requires to be defeated (again). We are in the midst of a war; this is not politics as usual. We live in trying perilous times.

The nation is living in Psalm 23: "Yea, though I walk through the valley of the shadow of death, I will fear no evil: for thou art with me." The only misnomer is many Americans have no clue what the short phrase "Thou Art" even means any longer.

Evil exists, and it is not something that existed only during biblical times

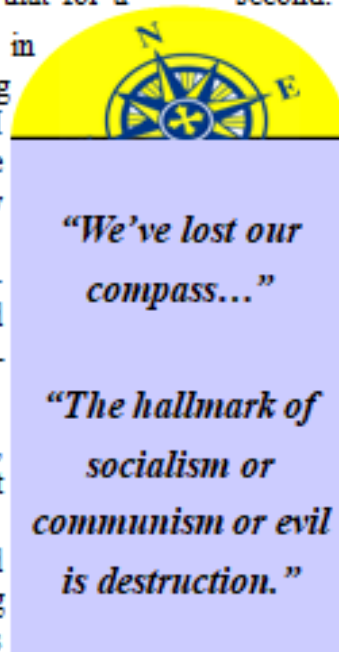

FDIC Contemplates Market Collapse, Hiding Alarming Data from Depositors

The FDIC's Systemic Resolution Advisory Committee (SRAC) held a meeting in November to discuss how the next market crash would occur and what steps would need to be taken to ensure not everybody tries pulling their money out of the financial system at the same time. One FDIC member noted that while institutions will soon be able to figure out the dire implications of a financial collapse, the general public should not, because that would lead to "unintended consequences." **The FDIC insures \$9 TRILLION of bank deposits with only \$125 billion worth of assets.** The FDIC cannot insure everybody in a crisis when many people want to withdraw their money all at once. A critic on Twitter wrote: "If this goes down during 2023 ... we can expect the mother of all Fed QE ... \$5 trillion instantly on the balance sheet expansion to bailout the banking system and massive amounts of Congressional stimulus and bailouts." The article concludes that Federal Reserve-orchestrated bail-outs – and more inflation – are inevitable if there is a market crash.

Federal Deposit Insurance Corporation (FDIC) officials recently discussed how to deal with the next approaching market collapse and hide alarming data from depositors to prevent bank runs, video of a meeting shows.

"You've got to think of the unintended consequences of taking a public that has more full faith and confidence in the banking system than maybe the people in this room do," one FDIC member noted.

"We want them to have the full faith and confidence in the banking system. They know FDIC insurance is there. They know what works. They put their money

in, they're going to get their money out." He claimed that although institutions will soon be able to figure out the dire implications of what's being discussed at the meeting, the general public should not, because that would lead to "unintended consequences."

"I would be careful about the unintended consequences of starting to blast too much of this out in the general public," he said.

In a fitting description of fractional reserve banking, another SRAC member lamented that although institutions don't want to see a "huge run" on their deposits, they likely will soon, which will bring about the need to impose bail-ins.

"People need to understand they can get bailed in, but you don't want a huge run on the institutions. But there are going to be. And it could be an early warning signal to the FDIC and primary regulators when these things happen," he said.

Unlike bail-outs, which involve a third party like taxpayers and governments rescuing failed financial institutions, bail-ins are a mechanism in which creditors of a failing financial institution are required to cancel some of its debts as part of a plan to save it from collapse.

One FDIC member claimed this economic "period of peacetime" will soon "flip faster than we saw in 2008."

"I do think it's hard to get a lot of demand for transparency right now, in this sort of period of peacetime, but that is going to flip and it's going to flip faster than we saw in 2008," he said.

Because of that, he said, it's necessary for financial institutions to quickly leverage "the social media world" with curat-

ed talking points to combat "disinformation" and "avoid rumors taking over the narrative."

Keep in mind, the FDIC insures \$9 TRILLION of bank deposits with only \$125 billion worth of assets.


In other words, only 1.3% of its holdings are in reserve.

It can't possibly insure everybody, especially in a crisis when many people want to withdraw their money all at once.



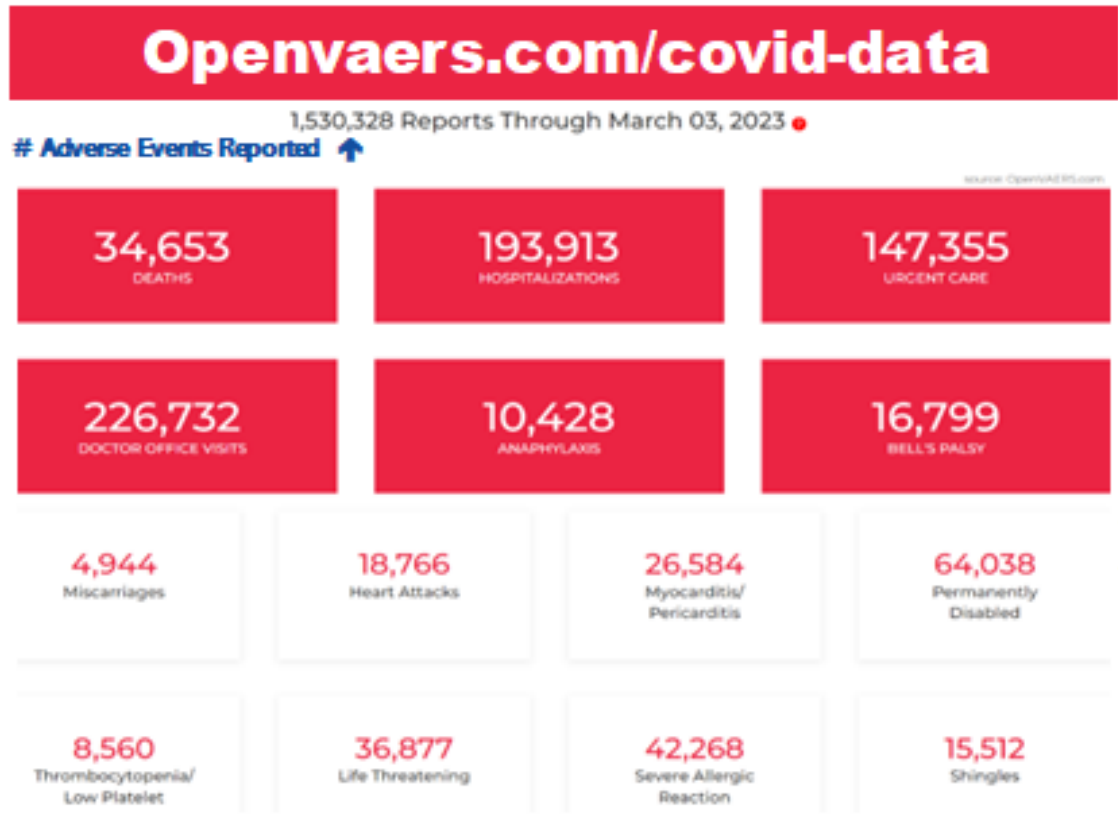

Google cuts 12,000 jobs

Google CEO Sundar Pichai announced the news in an email to staff, saying the company needed to focus on key priorities — like artificial intelligence.

Google is cutting approximately 12,000 jobs — the latest technology firm to initiate significant layoffs as inflation rises and global markets brace for a downturn.

Google CEO Sundar Pichai announced the cuts in an email to staff on Friday and a blog post. The job losses constitute around 6 percent of Google's global workforce, compared to recent layoffs at Microsoft (10,000 jobs or 5 percent of the workforce), Amazon (18,000 jobs / 6 percent), and Meta (11,000 / 13 percent). Earlier this month, Google's parent company Alphabet announced much smaller cuts at Verily, its health-focused subsidiary, and Intrinsic, a subsidiary developing software for industrial robots.

In his blog post, Pichai said the layoffs marked a moment for the company to

“sharpen our focus, reengineer our cost base, and direct our talent and capital to our highest priorities.” The CEO noted that artificial intelligence would be a key area going forward.

“I am confident about the huge opportunity in front of us thanks to the strength of our mission, the value of our products and services, and our early investments in AI,” said Pichai. “To fully capture it, we’ll need to make tough choices.”

Although Google made significant early leads in AI with investments like its 2014 acquisition of research-focused AI lab DeepMind, the company has been wrong-footed in recent months by more daring rivals like OpenAI, which launched its buzzy AI chatbot ChatGPT on the web last year. OpenAI has forged a deep partnership with Google rival Microsoft, with the latter promising to integrate its AI tech into products like search and office software.

In Google's earnings re-

port last October it announced revenue of \$69 billion and profit of \$13.9 billion; marking growing revenue (up from \$65.1 billion the previous year) but shrinking profits (down from \$18.9 billion the same quarter in 2021). Earlier last year, Pichai signaled that the company would be slowing down on hiring, saying Googlers would have to work with “greater urgency, sharper focus, and more hunger than we’ve shown on sunnier days.”

In May, America First Legal released a primer on the Biden Administration's globalist plan to surrender sovereignty to the corrupt WHO. AFL also launched two Freedom of Information Act (FOIA) investigations into the Biden Administration's obsession with transferring American sovereignty over public health policy to an unaccountable foreign body.

And then in July, a coalition of states filed a petition for rulemaking with HHS, asking for the deletion of problematic regulatory provisions—that were discretely slipped into the Code of Federal Regulations during the final days of the Obama Administration—that unlawfully delegated the authority to invoke health emergency powers solely based on decisions by the WHO. In October, the Biden Administration denied that petition.

The globalist WHO, which is currently led by Director-General Ghebreyesus, a former member of the Ethiopian Tigray People's Liberation Front, and apologist for the Chinese Communist Party, has no place in defining what a public health emergency in the United States is. HHS has no right or authority to cede American sovereignty, especially State sovereignty, to the corrupt World Health Organization.

More people are writing to tell us that in many cases, we didn't mention a person's vaccination status. There is a good reason for that. None of the clubs want to reveal this information. None of their sponsors want to reveal it. The players have been told not to reveal it. Most of their relatives will not mention it. None of the media are asking this question. So what should we do? Stop this now? No, we will collect as much information as we can, while it is still available, because eventually, more information will come out, and we will be here to put it together. Will it mean anything? We don't know. What we do know is that there is a concerted world-wide effort to

make this information go away, so that fact alone tells us it must be collected, investigated and saved so other researchers can look at it to see if there are any useful patterns.

We replaced about a dozen occurrences of the word “shot” with “injection” because translation into other languages is improved, on advice from a reader.

We really appreciate the athletes named in this list (or their families) who have confirmed what happened to them so the truth can be known. They care about their fellow athletes, even if the clubs,

their sponsors, media, politicians and so-called health professionals do not.

Contained in the list are many professional athletes and high level amateur athletes. It would not be sensible to try to report the death of every person on the planet, so we have selected a category of persons who should be fit enough to lead a long and healthy life. This means that provided a person is reasonably fit, healthy and does some athletic activity, rather than an unfit “couch potato,” then they can be included in this list. Needless to say, these are only the persons reported to us by readers or that we discovered during research. Also note that almost all of these have been reported in the media. In some cases, we have a person's own social media or reports from their family. For example, vocal pro-vaccination athlete Uche Nwaneri, the 38-year-old former Jacksonville Jaguars American Football player who said anti-vaxxers should be jailed – until he died suddenly.

There are many countries or states with large populations, that have almost no reports in our list. That probably means events are not being reported to us. The true death and injury numbers are likely to be very much higher than we list here.

The International Olympic Committee in Lausanne, Switzerland, studied documents from international data banks from 1966 to 2004. Those documents indicate 1,101 sudden deaths in athletes under 35 years of age, an average of 29 athletes per year, the sports with the highest incidence being soccer and basketball. (NIH Document)

A study by Maron on sudden death in US athletes, from 1980 to 2006 in thirty-eight sports identified 1,866 deaths of athletes with cardiac disease, with a prevalence of hypertrophic cardiomyopathy.

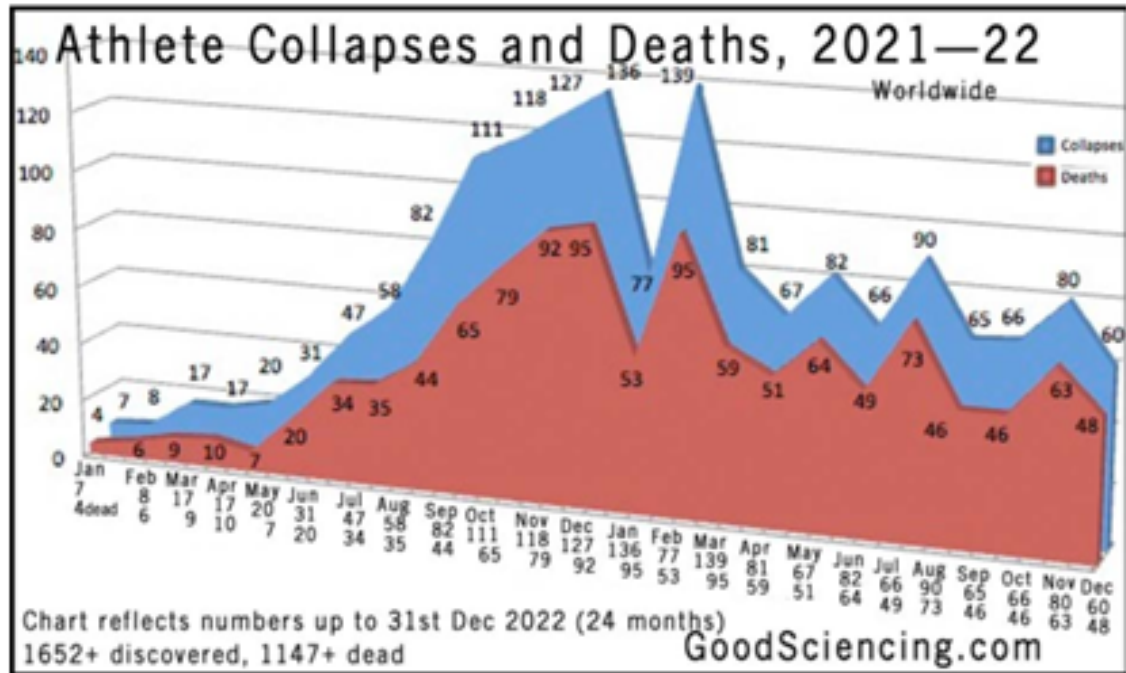
2005 to 2006 averaged sixty-six (66) deaths per year, with 82% of those occurring during competition or training.

In 2021 and 2022 so far, cardiac disease has not been mentioned. Hypertrophic cardiomyopathy was mentioned twice, but those two reports were listed in the "not vax related" list. "Enlarged heart" was only mentioned three times, but there was no indication this was a long-term or recent issue (possibly due to vaccine injury).

The chart (above right) shows that in prior years, there were only 66 deaths per year, but there have been 89 reported in January 2022, so far.

'Is curing patients a sustainable business model?' That's what Goldman Sachs analysts asked in an April 2018 report on 'The Genome Revolution'. The analysts didn't think so, arguing that there was little money to be made on 'one shot cures'. But there is endless money to be made from chronically injured

people, they argued.

A recent report analyzing Bureau of Labor Statistics in the US up to November 2022 by the Phinance Technologies Team shows a dramatic increase in disabilities in people aged 16-64 which coincides with the rollout of the vaccines. Treating those people will certainly be a viable business model for Big Pharma for the foreseeable future.

How does this relate to the extraordinary level of injury and death that experts say the Covid vaccines are causing?

Dr Richard Ennos, a retired professor of evolutionary biology at Edinburgh University, is the latest eminent academic to call for the immediate withdrawal of the mRNA Covid vaccines writing that 'Glaring safety signals are apparent, indicating harm to the lymph system, the heart and to female reproduction.'

Dr Ennos came to this conclusion after conducting a thorough analysis of detailed data collected by the UK's Medicines and Healthcare products Regulatory Agency (MHRA)

through its Covid-19 Yellow Card vaccine adverse event database which the agency finally agreed to release after stalling for more than 18 months. It claimed that it would be too onerous to pass on the raw data despite the fact that the raw data is sent immediately to Pfizer and Moderna.

Dr Ennos is scathing about the MHRA writing that its regular summary of Yellow card reporting has been 'an exercise in defending the Covid-19 vaccines from criticism rather than defending the UK public from the Covid-19 vaccines'. He damns the reports as lacking any scientific rigor, not providing a single piece of statistical analysis to support conclusions and calls them 'an affront to the huge number of individuals who have

been injured or killed doing what they believe to be "the right thing" (to do)'.

Ennos dedicates his report to the innocent UK public and to the dedicated physicians who filed the Yellow Card reports, writing, 'I would like you to know that your suffering and endeavors have not been in vain.'

The work of Ennos bookends an open letter sent by Dr Tess Lawrie in June 2021 to Dr. June Raine, chief executive of the MHRA, demanding the halt of the mass rollout of COVID vaccines after discovering a 'high number of COVID-19 vaccine-attributed deaths and adverse drug reactions that have been reported via the Yellow Card system'.

Dr Ennos and Dr Lawrie are not alone. In the last fortnight Dr Joseph Fraiman, lead author of peer-reviewed research re-analyzing the Pfizer and Moderna Covid vaccine trial data, called for an immediate suspension of the vaccines saying, 'We have conclusive evidence that the vaccines are inducing sudden cardiac death.' Before him, prominent UK cardiologist Dr Aseem Malhotra, who also conducted a peer-reviewed study of the vaccines, called for their suspension. Top US cardiologist Dr Peter McCullough has also called for an immediate suspension of the vaccines saying, 'I'm going to be very clear about this. The vaccine is killing people and it's killing large numbers of people.'

Masanori Fukushima, a distinguished oncologist, professor emeritus at Kyoto University, and Director of the Translational Research Informatics Centre, agrees. Together with other eminent Japanese professors he has called for an immediate halt to the use of the mRNA vaccines which he describes as 'an unprecedented disaster' saying he can't imagine how many people have really died in Japan and the report of 2,000 deaths is just the 'tip of the iceberg'.

Masanori is a specialist in pharmacy-epidemiology, which he describes as the 'study of stopping drug disasters'. He has been actively involved in evaluating the Covid vaccines and is planning to sue the Japanese government for refusing to disclose vital information that could save lives.

Masanori says he asked government officials to disclose Covid mortality in the vaccinated compared with the unvaccinated on 1 August 2022. After stalling for two months, they refused. **Apparently, the government disclosed this information earlier and it had shown that in people under 65 years the mortality rate was lower for unvaccinated people than for vaccinated people. Masanori thinks this was embarrassing for the government so they have refused to disclose any further information.**

Interestingly, from May to December 2022, the NSW government also dis-

closed Covid deaths by vaccine status and these statistics also showed a slightly lower rate of mortality for the unvaccinated compared with the vaccinated. Like Japan, NSW will also no longer disclose Covid deaths by vaccine status.

Yet when the Centers for Disease Control and the Food and Drug Administration investigated a possible link between Pfizer's bivalent Covid/flu vaccine and an increased risk of stroke, they stated within days that it was 'very unlikely' that the vaccine was the cause. Yet as one pundit observed, the Securities and Exchange Commission repeatedly investigated Bernie Madoff without finding evidence of fraud.

Part of the problem appears to be regulatory capture on a grand international scale. Dr Raine gave a speech in which she boasted that the MHRA had gone from being a watchdog to being an 'enabler' and that in regulating the Covid vaccines the MHRA 'tore up the rule book'.

In the US, there is a revolving door between big pharmaceutical companies and the regulatory agencies of whom Scott Gottlieb is only the most prominent example. He worked at the FDA, then in the private sector, returned to be FDA commissioner and since 2019 has served on the board of Pfizer. Similarly, Stephen Hahn served as the head of the FDA from 2019 to 2021 before becoming the chief medical officer of Flagship Pioneering, the venture firm behind Moderna.

Another problem is the fact that the vaccines have been authorized under emergency use authorization in the US and provisionally in Australia, giving pharmaceutical companies indemnity which appears to have made them indifferent to the harms vaccines have caused. And control of social media by the Biden administration in the US and the Trusted News Initiative internationally have shielded vaccine manufacturers from almost all criticism. So far, it appears to be a more sustainable business model than curing patients.

We see the temperature going up and then we see the CO2 coming up. The CO2 lags behind that increase, it's got an 800 year lag, so the temperature is leading CO2 by 800 years."

There have now been several major ice core surveys, every one of them shows the same thing. The temperature rises and fall, then, after a few hundred years, carbon dioxide follows. "So obviously, carbon dioxide is not the cause of that warming. In fact, we can say that the warming produced the increase in carbon dioxide."

"CO2, clearly cannot be causing temperature changes. It's a product of temperature., It's following temperature changes."

The ice core record goes to the very heart of the problem we have here. They said, if the CO2 increases in the atmosphere, as a greenhouse gas, then the temperature will go up. But the ice core record shows exactly the opposite. So the fundamental assumption, THE most fundamental assumption of the whole theory of climate change due to humans, is shown to be wrong.

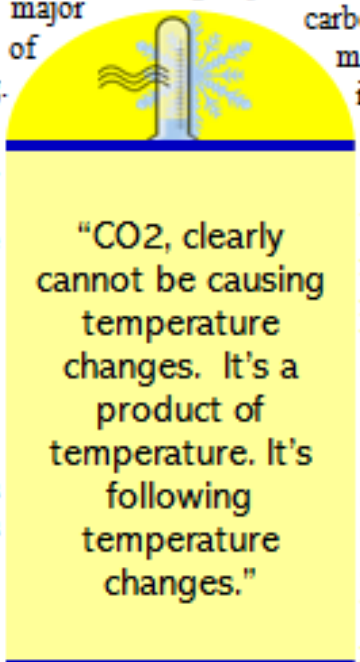
But how can it be that higher temperatures lead to more CO2 in the atmos-

What's more, humans are not the main source of carbon dioxide. "Humans produce a small fraction in the single digits, percentagewise, of the CO2 that is produced in the atmosphere. Volcanoes produce more CO2 each year

than all the factories and cars and planes and other sources of man-made carbon dioxide put together. More still, comes from animals and bacteria, which release about 150 gigatons of CO2 each year, compared to a mere 6.5 gigatons from humans. An even larger source of CO2 is dying vegetation from falling leaves, for example, in the autumn. But the biggest source of CO2 by far, is the oceans.

Carl Wunsch, is professor of oceanography at MIT. He was also visiting professor of oceanography at Harvard University, and University College London, and a senior visiting fellow of mathematics and physics at the University of Cambridge. He is the author of 4 major textbooks on oceanography. "The ocean is the major reservoir into which carbon dioxide goes when it comes out of the atmosphere or from which it is re-emitted to atmosphere. If you heat the surface of the ocean, it tends to emit carbon dioxide. Similarly, if you cool the ocean surface the ocean can dissolve more carbon dioxide," Says Carl Wunsch.

So, the warmer the oceans the more carbon dioxide they produce and the cooler they are the more they suck in. But why is there a time lag of hundreds of years between the change in temperature and the change in the amount of carbon dioxide going into or out of the sea? The reason is that the oceans are so big and so deep they take literally hundreds of years warm up and cool down. This time lag means the oceans have what scientists call a memory of temperature changes.

"The ocean has a memory of past events running out as far as 10,000 years. So, for example, if somebody says, 'Oh, I'm seeing changes in the north Atlantic. This must mean the climate system is

changing.' It may only mean that something happened in a remote part of the ocean decades or even hundreds of years ago whose effects are just now beginning to show up in the north Atlantic.

The current warming began long before people had cars or electric lights. In the past 150 years the temperature has risen just over .5 degrees Celsius, but most of that rise occurred before 1940. Since that time, the temperature has fallen for 4 decades and risen for 3. **There is no evidence, at all, from earth's long climate history, that carbon dioxide has ever determined global temperatures.**
